

#### Founder Chairman's Message

# Dear Friends.

The year 2012-13 has been a year of satisfying progress for UVCT. While we have been focusing on empowerment of adolescents, a new platform was given to us to empower women in Kapasheraand Samalka. (Kapasera slum area is called by some as 'Dharavi of Delhi'). A Gender Resource Center has been started under the aegis of Mission Convergence of Government of GNCT, Delhi. It seemed a cost effective program,

touching the lives of marginalized and under privileged sections of the Society. In these GRCs, besides conducting some vocational courses, regular sessions are held for improving health, legal awareness and literacy levels. Our outreach programs in South West Educational District of Delhi, under National Children Fund (Ministry of Women and Child Development), came to an end but with promising leads for such programs not only in Delhi but also in other States. Our long continuing governmental support from the Ministry of Youth Affairs and Sports is renewed through their National Program for Youth and Adolescent Development (NPYAD) Scheme. However, the Working Groups on Adolescents constituted by different Ministries, in their run up for the 12th Five-Year Plan, are still to announce their programs/Schemes.

Our progress for spreading awareness amongst the migrant workers in Wazirpur Industrial Zone was appreciated, and yet another venue Narela Industrial Zone was awarded by the Delhi State Aids Control Society (DSACS). Vocational programs in our existing Centers and outside Chapters have also been geared up. In this regard, we received valuable financial support from, respectively, Oriental Bank of Commerce; Central Bank of India; and well-known philanthropist, Shri Vijay Kumar of Vijay Nirman Coy. Such financial support to well-meaning projects would always strengthen organizations of our kind to put in extra efforts and make hard pursuits. In this context, I commend the unusual efforts of Bhiwandi Center where more than 500 girls, mostly from the Muslim Community (traditional with their 'Parda' system) joined the programs in our sub-Centers(started thoughtfully within their own localities) to learn Life Skills and a wide range of vocational courses. In this regard, we are grateful to Shri R.K.Dubey, the then Executive Director (presently CMD of Canara Bank) and Shri Ratnakar, the then GM, CSR Wing of Central Bank of India, who understood our commitment to the cause and generously supported the programs in Bhiwandi by donating Rs. 7.00 lakhs.

The brand Festival of UVCT – the 'Hum Kishore' -6th in the series, went off very well, attracting more than 100 schools and promoting keener competitions at 6 venues. We are extremely grateful to Bharat Heavy Electrical Limited (BHEL), who came forward as Platinum Sponsor (Contributed Rs. 12.00 lakhs), along with organizations namely, Rural Electrification Corporation Ltd. (REC) and National Building Construction Corporation Ltd. (NBCC) (contributed Rs. 1.00 lakh each). This year, the Festival had the theme "Young India is Healthy India".

The Executive Committee and Members, besides the staff of UVCT, had put in their best efforts in helping the organization to move up from an annual budget of Rs. 70.00 lakhs (2011-12) to Rs. 108.00 lakhs (2012-13). I am thankful to all our benefactors and well wishers and looking forward for greater activity in the coming years.

# Who we are and what we stand for?



Our Origin: Urivi Vikram Charitable Trust (UVCT), a nongovernmental and non-profit Organization, was established in India in 1991. It was founded by Dr U.N.B. Rao and his wife, Urivi Chaya, with the support of a few well-meaning friends, in fond memory of their only son, Urivi Vikram, who was killed at a prime age of 20/21 years, in a road accident. Rao family tried to reverse the 'arrow of sorrow' and worked to empower adolescents and young adults, especially from lower S.E.S. UVCT's priority target group comprises drop-outs and under-achievers, besides school going children. UVCT has a motto of finding ways and means to transform the India's 'Burden of Population' into 'Asset of Human Resources', through a process of empowerment, rather than of control. Besides its 14 centers functioning in 6 State chapters and alliance with a number of other organizations and institutions, UVCT expanded its horizons in the global arena with UVCT USA. Efforts are afoot to get many more Centers started through our Corporate Associates and PSUs.

During the last 22 years, UVCT evolved specific projects catering to the needs of young adults. These projects are basically (i) Psychological Counseling and Career Guidance (Project Prerna); (ii) Harnessing the enormous energies of drop-outs and under-achievers (Project Shakti); (iii)

Vocational Training and Extending support to find meaningful avocations (Project Sahara); (iv) Reformation and rehabilitation of children in conflict with Law, through Life Skills Education and Vocational skills (Project Parivartan) and (v) Financial assistance to those children who are academically bright, but financially weak (Project Ummeed). Program 'Sahara' is also integrated with program 'Shakti' to ensure linkages to livelihoods.

Alongside, UVCT has also been actively involved in advocating that 'adolescence' (age group: 10 to 19 yrs, as per WHO) is a 'distinct and critical stage' of Human Development and that adolescents should have specific schemes for their nurturing and development in the national framework. Our work is based on

holistic approach and to promote an all-round personality by addressing all stake-holders. The Trust also got built in 2007, the first ever 'Urivi Vikram National Centre for Adolescents(UVNAC)' in Dwarka, New Delhi-110077, which is being used for conducting and promoting in-depth studies and run a number of projects and training/orientation programs.

#### What we stand for?

Mission: To strengthen young adults through empowerment rather than control, and bringing into mainstream the drop-outs, under-achievers and childrenin- conflict with law, especially from those belonging to marginalized and deprived sections of society, and help them to become socially responsible and economically productive citizens of India and the world.

Vision: Finding ways and means to transform India's 'Burden of Population' into an 'Asset of Human Resources' and thereby, help ensure better utilization of India's demographic dividend, resulted due to growing number of younger populations (Adolescents constitute 22% of India's population: 2011 census); empowering the Generation next - by providing physiological Counseling/Career





Guidance, and extending Life Skills Education, Vocational Skills and other needed capabilities to find suitable avenues for livelihood and strive for betterment; helping to develop a confident young India - unafraid of change and changing social and professional situation - equipped with specialized skills and ability to learn newer skills and newer methods of working; and networking with national and international organizations - both Governmental and non-Governmental - working for adolescents and young adults, and thereby build a massive support base to promote a better future for the mankind.

Objectives: Develop awareness through seminars, group discussions and camps to help youth find solutions to their problems- psychological, financial, ethical and social; and to help acquire a realistic valve system that is conducive to the development of a healthy society; Develop educational and skill training programs for school dropouts, to enable them to become socially and economically useful citizens of India (world);

- Develop the concept of oneness of all religions and love for the homeland in the youth, by raising their level of consciousness;
- Develop counseling centers for disturbed youths;
   Establish rehabilitation centers for juvenile delinquents to provide both emotional support and skill trainings;
- Develop skills among the young adults and women, in regard to textiles, handicrafts and other ancillary Industries; and
- Endeavor to promote equality of status and opportunity, assuring dignity of individual and the unity and integrity of the Nation, services for the hygiene, health and happiness for all the citizens of India.

28th April, 2009

: UVCT USA chapter was launched in New York, followed by net working with Adolescent centric organizations in USA, Japan and Australia.

9th Sept, 2008

: Dr. A.P.J. Abdul Kalam, former President of India graced the 17th Foundation Day Celebrations and inaugurated SAIL's Seminar room at National Centre for Adolescents.

15-18th Jan., 2008

: First ever Hum Kishore Festival was launched by UVCT with Rolling Trophies in 14 events of competitions such as Dance, Song, Essay Writing, Debates etc.

5th Sept., 2007

: Urivi Vikram National Centre for Adolescents was inaugurated by Shri Tejendra Khanna, Lt. Governor of Delhi.

27-29th July, 2005

Second National Seminar on 'Adolescents: Vision 2020' was held by UVCT in New Delhi with 15 other organizers as partners in action and participated by about 500 adolescents drawn from different parts of the country and involving about 60 Adolescents' Experts. Dr. Karam Singh, Dr. S.S.Verma and Shri M.V.Rajshekharan, the then Minister of Planning, Government of India graced the occasion.

4th March, 2005

Foundation Stone for building the National Centre for Adolescents was laid in Sector 22, Dwarka, New Delhi by Mrs. Shiela Dixit. Chief Minister, Delhi.

17th Sept., 2002

: UVCT held Regional meet for "National Policy on Adolescents", in collaboration with Common wealth Association of Media Persons. Shri K.C.Pant, the then Dy. Chairman, Planning Commission and Shri Vikram Verma, the then Minister of Youth Affairs and Sports were the Chief guests.

August, 2002

 UVCT's Founder Chairman Dr. U.N.& Rao received Ph.D. from IIT, Delhi on theme 'Proactive Policing Approach and Attitudes of Adolescent Students'.

1st August, 2002

Life Skill Modules were brought out by UNIAWG, wherein it was specifically acknowledged that UVCT's Shakti Program formed the basis for IAWG proto-type program on developing Life skills modules for School drop-outs and out-of-school Adolescents.

1st June, 2001:

 UVCT's contribution in Life Skill Education, Counseling and work of adolescents were duly appreciated and included in the report of the Working group of Adolescents (TFYP Working Group, 2001) for the 10th Five Year Plan (2002-2007).

22nd January, 2001

Planning Commission set up first ever Working group on Adolescents, prompted by UVCT's advocacy document; UVCT was included in the Working Group and Drafting Committee.

5th October, 1999

 Dr. Michael Vlossof, the then UNFPA Chief in India, visited the Trust and appreciated the efficacy of "Shakti" Program, during UVCT Foundation Day Celebrations.

22-24 July, 1999

: First National Meet on theme 'Policy for Young Adults' was held, Shri T.N.Sheshan, former Chief Election Commissioner of India and Dr. Karan Singh, as Chief Guest. It was attended by 300 young adults, about 80 experts and 40 Govt. representatives.

13-14 Feb., 1999

: UVCT's Mumbai Chapter was launched.

25th Dec., 1995

: Shakti Children participated in All India Rajiv Gandhi Festival and bagged All India Team championship in Arms Wrestling, were honored by Smt. Sonia Gandhi.

3rd October, 1995

 Launch of Project "Shakti" to mainstream school drop-outs and under achievers; launched by Shri Madan Lal Khurana, the then Chief Minister, GNCT, New Delhi.

18th July, 1993

: 'Prerana' a developmental project on Counseling and Career guidance was launched

12th Dec., 1991

: Urivi Vikram Charitable Trust was established on the first 'Barsi' (death anniversary) of Vikram.

13th Dec., 1990

URIVI VIKRAM aged 20/21 years, was killed in a road accident (ran over by a bus).



# 'Prerana' \(\to\) 'Shakti' + 'Sahara'= Livelihood

- Since inception changed the lives of 1.5 lakh young adults.
- This year touched approximately 30,000 through counseling and careerguidance.
- 800 youngsters from both government schools and private received the individual counseling services free of cost.
- 600 Parents and 100 Teachers were addressed under NCF project.
- 7499 students were addressed under NCF project.
- Imparted trainings to 300 young adults under National Program for Youth and Adolescent Development (NPYAD) - Ministry of Youth Affairs and Sports.

#### Observations from LSE Programs:

- It was observed that the nonspeakers at the start are received to speak by middle of the sessions;
- The participants enjoyed the activity of "Group Discussion" and writing their thoughts on the charts the most.
- Success rate is 60-70%.
- Outreach programs in rural areas and governmental schools made a difference.
- Reorientation of teacher and parents is as essential as of children.

Over the years, an inter-project approach is evolved to address different schemes/projects — all ultimately to empower the participants and link them to livelihoods. 'Prerana' concepts (psychological counseling and career guidance) formed the base, especially for school-going children while 'Shakti' focused on Life Skills education for out-of-school adolescents. After having provided the adolescents with the needed mental make-up, and the life skills to move forward (especially for drop-outs and under-achievers), Project 'Sahara' (vocational training and placement services) helped them to a road of self-employment and /or get into possible job avenues. Some of the beneficiaries even opted to improve their studies and look for better avenues.

#### In-House Counseling & Orientation programs

A full-fledged Counseling and Career Guidance Centre (CGC) that had been established in 2007 at Urivi Vikram National Center for Adolescents (UVNAC), Dwarka continued to extend services to our



wards at Ramesh Nagar, Tagore Garden, and Kapashera also. The CGC is equipped with psychometric tests, relevant manuals, Career and psychological pamphlets and other technical aids. As many as 800 adolescents from both government schools (free of cost) and public schools (nominal fees), and beneficiaries of UVCT Centers received individual counseling services. Students with concerns, identified during outreach programs, were specially invited and given the facility.



In about 100 cases, parents also participated in the counseling sessions. We reached out also to more than 600 parents and teachers through our Workshops / Seminars. The topics covered were:

#### For Adolescents

- Time Management and Interpersonal Relations.
- Study habits and techniques to improve memory. Confidence building, Problem solving and Public Speaking.
- Communication Skills and building a positive personality.
- Self grooming and how to be a leader.
- Reproductive Child Health & Personal Hygiene.
- Preparation for exam and presentation skills.

#### For Parents & Teachers

- Handling emotions of children and coping with high risk behavior.
- Know your growing child and how to help them choosing a right career.
- Examination blues and role of parents.

# Project under National Children Fund (NCF):

UVCT was given the project "Empowering Children by addressing inner conflicts and to make them economically productive and socially responsible". This year we reached out to 50 more schools in South-west and West Delhi. In total 7499 students were reached. In addition to this, 600 parents and 100 teachers were addressed, equip bring them to deal with the growing needs of the adolescents, to enhance young people's skills in decision making and help becoming economically productive and socially responsible citizens. As per the MOU signed between Urivi Vikram Charitable Trust and National Children Fund, UVCT undertook the following four activities:

a) Outreach Programs: Conducted in both Govt./ Public



schools, to make them aware of the stages of adolescence and the associated conflicts, with a view to empower them for overcoming those pressures, and to make known to them about the ever-growing number of careers.

- Adolescent workshops: Empowered the children and make them confident and focused individuals through interactive sessions.
- c) Parents and Teachers workshops: Equipped them to understand their growing children and their needs and help coping with their concerns.
- d) Individual counseling: Addressed individual's conflicts and concerns, of identified individuals during outreach and workshop programs.

#### Observations and Outcomes of the NCF Project

- Through the sessions, it was reaffirmed that the 'Adolescence' stage of rapid physical, Psychological, emotional and behavioral changes. It could be termed as a 'restless and confused phase too'.
- Bulk of the students in these Government Schools were from the lower and below poverty line strata and lacked proper guidance and counseling, and their family members lacked awareness about the emerging opportunities except having a belief that literacy brings



prosperity to their children. Two/ three individual sessions with the these children seemed to have made a difference to realize their potentials and plan for a meaningful future; more such interactions, by way of booster-shots, are desirable;

- Children of some neo-rich families(who made money through land sales in South-west Delhi) were not easily amenable and called for hard pursuits to show them a career path; and
- Parents and teachers required lot of persuasion to understand the changing aspirations and worsening concerns of their wards.

#### National Program for Youth and Adolescent Development (NPYAD) Scheme, Ministry of Youth Affairs and Sports, GOI:

Life Skill education workshops (short term) for ten days each were conducted at UVCT's Ramesh Nagar and Tagore Garden Centers in Delhi, and Visakha Center (Andhra Pradesh) and Bhiwandi Center (in Maharashtra). The workshops were attended by more than 300 students. The

main objectives of the workshop were to equip the participants with the skills — thinking, social and communication - to deal with their day to day requirements. Participants were empowered through various activities to resolve their inner conflicts, build up their self esteem, health and hygiene, RCH, inter-personal relations, how to overcome peer pressures and save from substance abuse, how to prepare for interview, etc. Participants took keen interest as the sessions were highly interactive and the topics were of contemporary value to them. In the post-course assessments, the participants were found to have undergone lifestyle changes which included:

- Positive behavior
- Promoted family values
- Reduced drug and substance abuse
- Healthy life style with reduction in risky behaviors
- Raised self-self-esteem
- Promoted gender sensitivity

#### YOUTH REACH'S 'YES' PROGRAM:

The Youth Reach-sponsored program for Life Skills Education and Spoken English with linkages to livelihood, continued during the year. It may be recalled that Youth Reach, a well known funding

> Organization, chose UVCT by appreciating its track record in Life Skills Education (Shakti) started the sponsorship program in March, 2010. The program differs from NPYAD of the Ministry of Sports and Youth Affairs, GOI to the extent that the program is based on Wrigley's 'Youth Empowerment and Success' (YES) model and each batch is to undergo both Life Skills Education and Spoken English extending for 3 months. The basic emphasis is that these beneficiaries, as far as possible, should get into some job or other. The program went off well, both in Tagore Garden and Ramesh Nagar, covering 233 beneficiaries during the year. The beneficiaries were given periodic inputs about job avenues and the facilitators the needed orientation, from time to time making the

program quite effective, resulting in linkages to employment for 155 candidates out of a total of 233 candidates. Some success stories are given below:



#### Some success stories in Delhi:



Rajesh was very diffident person with complex of his low income family back ground. He migrated to Delhi in search of job. But couldn't get anyone, very soon he realized that he must have any skill to get the job. So he decided to join computer course with UVCT at a nominal charge.

Here he came to know about life skill program that is the brain child of UVCT. He got himself enrolled in this program. This training coupled with life skill education made him a very confident person. Today he is working as a designer in a firm. His parents are very happy and bless UVCT for making best out of their child.



Same is the story of Heena, Rukhsaar, Bhawna They came to know about UVCT beauty culture course Through a friend of theirs they joined the course, after completing the course now they are working in different beauty parlors with a new found esteem and confidence.



Md. Vajid originally belongs to Meerut. After a major tiff with his father he had come to Delhi for seeking a job. But he was not fluent in English and had very low confidence. One of his friends suggested joining the Life Skill and Spoken English courses at UVCT. Here in life skill modules

he understood the importance of the good relationship, respecting elders and empathy. He has gone back to his home town and is helping his father in their family business. His father is in very high praise for UVCT courses.

Ritu Gupta was introduced to UVCT by a friend of hers; she was a school dropout and was not able to get a job anywhere. She is the 5th child of her parents but due to very hard family conditions they could not support her education. She joined life skill classes and spoken English in UVCT. In couple of months she gained the necessary skills and confidence. Today, she is working as an assistant in a doctor's clinic. Her parents are very happy at her achievements and UVCT's contribution in providing her livelihood.

#### Photovoice program for pedestrian safety as perceived by adolescents:

The program sponsored by Safe Kids Foundation, which was started in February, 2010 suffered a stalemate due to a dispute between PWD and MCD of Delhi Government, over the alignment and repairing of the selected location and the road. On careful scrutiny, it was found that the trijunction at Kendriya Vidyala (Tagore Garden) with Rajauri Garden to Khayala road was most crucial for school going children of not only Kendriya Vidyala but also to other schools in the neighborhood. About 10,000 students pass through this junction which is chaotic at the beginning and close of the school time. In due consultation with Traffic Department and School authorities, the junction was chosen for development and making it safe for pedestrian students. UVCT got blinkers installed with the help of Delhi Traffic Police but installation of signages and Speed Breakers besides Zebra crossing is remaining to be done. UVCT is continuously pursuing with the relevant authorities, concerned Divisions of different Departments. A Team of Safe Kids Foundation led by Mrs. Rupa Kothari also visited the spot on 22.2.2013 and appreciated the stalemate. Vigorous efforts are afoot to complete this project at the earliest.

#### Special Career Workshops:

Career Guidance Workshops for Basava International School: UVCT was approached by management of Basava







International School, a prestigious school in Dwarka, to hold a career session for its XI grade students. The purpose was to equip them to choose a stream and pave way for careers of their choice. A batch of 45 students attended.

In-depth and research studies on issues related to adolescents: UVCT has taken up two major in-depth studies in respect of (a) Adolescents and Crime, and (b) Communication between Adolescents and Aged.

#### Project Sahara:

Once we provide the young adults with counseling, career guidance and life skill education, empower them and support them to a road of self reliance and income generation. Started in November 1995, the project provides a livelihood umbrella to those in need. UVCT supported program, works in 6 states and 11 centers to train youth in tailoring, computer skills, typing, beauty culture, bag making, industrial stitching Children are given vocational training in various marketable skills together with development of entrepreneurial skills and job training aspects to prepare the trainees to obtain a job or start their own businesses. It is also integrated with UVCT's Life skills Education Program. A placement program monitors the progress of ex students and helps them in their

endeavors. A profile of the beneficiaries and some success stories are given herewith in succeeding pages. Salient features of the program are:

- Vocational training in marketable skills
- Tie-up with 'Jan Siksha Samsthan' and other NGOs for up-gradation of training inputs
- Accreditation by National Open School Beauty Culture, Stitching & Embroidery, Typing and Word processing.
- Integrated with job training and/or entrepreneurial Skills as value addition
- Placement support through networking with industrial establishments, other vocational training centers and NGOs.





#### STATISTICAL VIEW OF UVCT VOCATIONAL TRAINING PROGRAMS IN DELHI DURING 2012-13:

Vocational training programs were conducted in Delhi at Ramesh Nagar, Tagore Garden and Kirari Centers. A total of 1345 beneficiaries completed their programs while another 450 were at different stages of their programs by the end of March, 2013. Besides regular beneficiaries, a batch of 74 students from three Govt. Senior Secondary Girls Schools, located in Motinagar, Kirtinagar and Ramesh Nagar availed the facilities at Ramesh Nagar, as part of their summer training. Ramesh Nagar Center was the most popular (attracting 200 to 300 beneficiaries a month), followed by Tagore Garden and Kirari. Though Kirari in North-west District was a new center, a steady growth was noticed in enrollment of beneficiaries at this place. It was seen that 31% of the participants were coming to the Centers from a distance of more than 2 Kms., whereas 6% travel from even longer distances. These figures show that the credibility of the UVCT Centers were well kept up.


It deserves a particular mention that there was a furor in Ramesh Nagar and around, from where the Centre received as many as 300 to 400 beneficiaries a month during summer vacations, when asked by MCD North Delhi to vacate the Ramesh Nagar Center to be utilized for some other purpose. Thankfully, UVCT got an alternative accommodation in Bindapur, a rehabilitation colony near Dabri (about 10 kms away from the present Centre ), where a new Center was being established in lieu of the Ramesh Nagar Centre (by July, 2013).

Most popular vocational programs remained (i) Computer applications – Basic, Tally and DTP (ii) Beauty Culture and Mehendi (iii) Typing and Short-hand (iv) Dress designing and (v) Cooking. About 50% beneficiaries were for computer courses which quality-wise and fees-wise cheap (A 3-month Basic Computer Course was just for a total fees of Rs.1000/- whereas in open-market it was for Rs 3 to 5 thousand).

An analysis has been undertaken of the beneficiaries from these three Centers, in order to understand the dynamics of the courses and attributes of the beneficiaries. Some important aspects of the analysis are as follows:

#### Age & Gender Factors:

Analysis of the enrollment data confirmed that youngest adolescent enrolled was of 11 years old (Spoken English) and the oldest beneficiary happened to be of 58 years old (compute course). A break up as per age groups is given in the picture.



Though UVCT had been thematically working for the adolescents (45%), its vocational programs were availed also by older students in the age group of 19 to 26 years (48%) from the marginalized sections of the society. Beneficiaries aged more than 27 years were 7.2%. The older people were mostly married women or widows (59% of the total) and divorced (0.4%).

In total, 68% of the beneficiaries were women and 32% were male, which trend persisted over the years.

#### SOCIAL PARAMETERS:

#### Living abodes:

The data revealed that highest number of beneficiaries are from slums - authorized slums (AS) were 36.2% and




unauthorized slums(UAS) 11.5%. Participants from Ruralurban villages from the neighborhood were 34.9%. Only 10.3% beneficiaries were from Societies developed by the Government for low income group (Janata flats). This data confirms that the UVCT are able to take care of marginalized and deprived segments of the society.



#### Family Income:

An analysis of family income of different beneficiaries of the Trust indicated that more than 50% of them were from families in the income track of Rs. 45,000/- to Rs. 80,000/per annum (4000 to 7000 per month). In these hard days,



such a low income range to feed big families is undoubtedly ground reality and the Trust has been over these programs with rock bottom fee structure of Rs. 100 to Rs. 300/- per month and the total period is from three to six months for various programs and thereby enabling these children from under-privileged and backward families also to meet the requirements. It may be pointed out that the courses offered by the Trust were available in open market with a fee structure of Rs. 1000/- to Rs. 10,000/- whereas our fee structure is only Rs. 300/- to Rs. 1500/-.


#### Caste & Creed Composition:

As a principle, UVCT admits aspirants without questioning and notifying their caste or creed, in a bid to promote social-integration. However, final tally indicates a total of 33% SC/ST population availed the benefits of the Center, besides 17.25% from Other Backward Classes.

In case of religion, though Hindus constituted the maximum (84%), Muslims were 9.7% and Sikhs 5.2%, though Muslim population in the area was stated to be only 4%. It appeared that the minorities felt encouraged due to the secular policies of the UVCT.


#### Residential Status and Migrants:

An analysis of the residential status of the beneficiaries indicated that migrants to Delhi from different States constituted 93% of the lot, whereas only 7% were those who had been living in Delhi for more than 20 years. It was found that 25.4% arrived in Delhi during the last one year, whereas 27% were those who were staying for one to five years. It was reported that 27% of the migrants were from



U.P. and 26% were from Bihar, whereas others constituted from Gujarat (7%), Rajasthan (5.7%). Punjab (4%), M.P. (4%) and Haryana (3%). The beneficiaries also include about 20% migrants from Southern and other States of India.

#### Reasons for Migration:





A further scrutiny of reasons for migration indicated that almost 30% migrated for better education opportunities in Delhi, whereas 17.5% came in search of employment or lack of employment (UE) in their native places. It was also seen that 15% of the migrants got employment (EO) in Delhi and thus, came over. Only 4.5% beneficiaries were those who migrated to Delhi after marriages. Reasons for migration are depicted in the picture.

#### Education and Aspirations:

Status of Schooling: It was interesting to note that as many as 49% of the beneficiaries were still in school and 21% were pursuing college education which indicated that most of the vocational programs were being pursued alongside academic pursuitlt indicates that the value of vocational skills are well understood as means for better employment








opportunities. In fact, 90% of the college-going students were those who pursued their education through non-collegiate and open learning modes, admittedly due to their economic situation coupled with their inability to meet high cut-offs for admission in regular colleges. Some young adults were also noticed for opting to combine part-time jobs with college education.

Reasons for dropping out: Dropouts and those who left studies constitute 17%. Their classification indicated that 39% did so because of their financial problems and 21%




due to failure in examination, besides 14% were those who got some employment or other.

Current Education level: Of the total beneficiaries, 39% were constitute those whose education level was between 6 to 12 classes, which is a matter of satisfaction for UVCT for its ability to take care of those under-privileged and potential drop outs/push outs. It was also seen that 10.5%

of the beneficiaries were graduates, who mostly did Computer Course and Spoken English in order to improve their chances of getting gainful occupations.

#### Reasons for joining vocational courses:

The analysis indicated that trainees had come to do the program for various reasons. While only 19.6% claimed to have attended the programs out of their own interest,




10.5% children made it clear that they were doing so due to family pressure. Another 4 to 4.5% people stated that they were not willing at all in these programs, who might be there only to while away their time. However, our subsequent interaction with the children through counseling sessions seemed to have improved their interest. 33% stated that they were doing these programs with a hope of getting some job, while 30% indicated that they were doing so with a hope to improve their present levels of income.



#### Difficulties in career shaping:

As many as 77% of beneficiaries categorically mentioned that they were facing problem in shaping their careers. They maintained that it was very difficult to find a career of



their choice and that they were quite often led by their parents, which has been a common phenomenon. UVCT through its career guidance sessions for their beneficiaries about new and emerging careers and how to choose a career, helped them to some extent. They were made known that they should understand the pros and cons of various courses before taking those up and should not lament once they take up a career. Of course, they were also told that they could always improve upon what they were doing but with proper effort. Some such inputs seemed to have helped beneficiaries in

emerging more confident and conversant. The above analysis and resultant findings continue to help UVCT in planning its vocational courses and seek appropriate support from

relevant Organizations.

#### Ummeed: Financial Support to the Needy

Launched in October 2007, the project provides financial assistance in the form of school/college fees, books & stationery and other required support to those students who are academically brilliant, but economically poor. This year we provided support to 9 more deserving persons, taking the total to a humble 17. We are on continuous look out for suitable candidates and benevolent donors to augment this Scheme.

#### UVNAC as IGNOU Study Center:

IGNOU Study Center-38013 started in UVNAC in 2010, continued to offer courses in B.S.W., B.A. (Psychology) and M.A. (Psychology); Masters in Counseling and Family Therapy and Certificate course in Guidance. The convergence between UVNAC and IGNOU helped about 650 students in not only improving educational qualifications and avail practical training facilities. The centre has drawn a number of house-wives and professionals and thus, promoting continuing education.

# Target Intervention(TI) Project in WazirpurIndustrial Zone:

In partnership with Delhi State AIDS control society (DSACS), we are implementing targeted intervention project in Wazirpur, since 2010. Delhi State AIDS control society continued supporting UVCT by renewing our contract and recognized our work by giving us another Targeted intervention project in Narela. The project focuses on awareness generation of HIV/AIDS, STD management, behavior change for safe sex among the target population. Three DICs have been setup to provide recreation and information on HIV related issues to migrants living within





the vicinity of DICs. Community outreach programs/events like carom competition, Musical chair, quiz competition, Rassa Kassi, Lemon Race were well attended and appreciated by the local community. Winners of competition were given prizes and medals. To garner continuous support from the local authorities and leaders, we do advocacy sessions and meetings with local leaders, religious leaders, police, NGOs, labour unions, labor contractors, factory union's leaders, factory owners, important stakeholders, municipal councilors, aadhar card agency, labour department, officers of election card office, ICTC centre, ART centers, TB dot centre etc. We were invited to demonstrate how to reach out to adolescents and women by properly counseling them on various occasions like World AIDS day, Red ribbon day, and Blood donation day.

#### Target Intervention(TI) Project in Narela Indusrial Zone

Based on our past work experience, expertise and outreach in the migrant community UVCT has been allotted TI project by DSACS in Narela, since 15th November, 2012. The



project focuses on awareness generation of HIV/AIDS, STD management, behavior change for safe sex among the target population .Three DICs have been setup to provide recreation and information on HIV related issues to migrants living within the vicinity of DICs.



#### Achievements in Wazirpur area:

- 18709 total registration of HRG's since inception after contacting 57680 individuals through contacting sessions,
- 4139 group sessions held.
- 20 functional condom outlets were established.
- 44 health camps organized and 4386 individuals were examined.
- 239 cases of STI were identified and treated.
- ICTC testing done for 846 migrants

#### Achievements in Narela Area are given below:

- 3063 total registration of HRG's from Dec. 12 to May 2013
- These HRGs were registered after contacting 17406 individuals' thorough contacting sessions, mid media, DIC, etc.
- 1475 group sessions held.
- 13 functional condom outlets established
- 15 health camps organized and 1745 individuals were examined
- 56 cases of STI were identified and treated.



#### **UVCT Gender Resource Centre (GRC), Kapashera:**

Urivi Vikram Charitable Trust, Dwarka was allotted GRC under the aegis of Mission Convergence from 15th September, 2012. Smt. Sheila Dikshit, Chief Minister of Delhi inaugurated the GRC, SSSK, Kapashera and Samalakha on 2.11.2012. The function was also attended by Parliamentary Secretary to CM Mukesh Sharma, MD Mission Convergence Santosh D. Vaidya, Dy. Commissioner (South-West) Vikas Anand and former MLA Vijay Lochav. The main purpose of opening GRC in Kapashera was to make all pro-poor services/benefits more accessible to the needy persons living in the vicinity. The UVCT GRC trying to make a difference in the lives of women and other poor persons in Kapashera and Samalka

rur-urban Villages. The Centre is imparting training to women in, industrial stitching, sewing and bag making. The Center is striving to make women useful for the society by providing learning skills. The trained women have started to contribute to the family income.

Apart from imparting training, the women in this center are empowered through useful information being provided in the GRCs. This Centre is also providing easy tips on health and imparting non-formal education. The Centre has become a catalyst of change. Besides this UVCT-GRC centre is giving information on all social schemes such as Laadli, Kishori, Annashri Yojana, Kerosene-free Delhi and Bhagidari Atta schemes.





## Success Story of Industrial Stitching

#### Some Success Stories: Stree Shakti Suvida Kendra (GRC)



#### Adult Literacy

I am Shakuntala, aged 49, hailing from a small village. Siryani of Haryana and presently living in Kapashera for the last 20 years. I was illiterate right from childhood due to family circumstances and social pressures for girls not to go

to schools. Whenever I saw children going to school in the morning, I would cry thinking that may be on one day I would be put in a school, but to no avail. I got married but became widow with four daughters and one son. When my children grew, I sent them to school. I had to take help from others to read any signage or board a bus. I was very introvert and incapable of handling situations because of illiteracy. I was not able to sign any document or read any instruction.

One day UVCT GRC's instructor came to my home during survey and convinced to come to GRC for learning. I found an angel in her; I realized my dream which I had nurtured for more than 45 years. On her suggestion, I attended the classes of adult education since November 2012. I was joyous when I held a pencil for the first time between my fingers. I learned alphabets of Hindi, English and started knowing colors and names of fruits/ vegetables. I also started learning counting up to 100 and do small sums of addition and subtraction. I was also taught to recite tables. Now I can reach out to anyone. I am no more an introvert; I can't express my emotions. Initially, I was like a blind and incapable of seeing anything. But, now I can see, read and understand, I am also able to read Ramayan and Gita. The great pleasure I get when I am able to help my own children. I am thankful to the Delhi Govt, which has helped me through UVCT GRC. God bless all those who helped me in realizing this dream.



#### Industrial Stitching

I am Babli, aged 30, hailing fromMainpuri District, UP. My husband is a Security Guard earning Rs. 4000/- a month. We have two daughters and one son.

It was difficult to survive in this

meager salary. We were not able to give good education to our children due to poverty and could hardly manage two meals a day.

I wanted to pursue some vocational trade but I could not do so as it involved fees and material cost, which was impossible due to our economic conditions. Then I came to know about UVCT Gender Resource Centre which was inaugurated by Honorable Chief Minister Smt. Sheila Dikshit in the month of November 2012, where different vocational trades were being taught, free of cost.

I joined 6-month course in Industrial Stitching with dedication. I am so proud because now I learnt to sew, and support my family. Within two weeks of completing the course, I got a job in a garment factory, but I preferred to work from my home. I started stitching from my home and take orders from some shops in the vicinity. I changed myself so much since I learnt industrial stitching. I am able to use some of my profits to purchase certain luxury items like fridge etc. I am contributing approximately 5000/month to my family expenditure.

I am grateful to UVCT GRC for providing me this training under the aegis of Mission convergence, Govt. of NCT of Delhi. May God give them strength to reach out to many more women who are in distress and need such help. I have myself taken a vow to teach women in my community or will link them to UVCT-GRC.



# UVCT Brand Festival: "Hum Kishore

(We, the Adolescents!!)

The 'Hum Kishore Festival' is a brand festival for the adolescents, to showcase their talents and hone their competitive edge. The festival is assertive approach for highlighting the aspirations of adolescents. The competitions are in 14 different fields, such as Painting, Indian classical dance, Debate, Elocution, Essay-writing, Folk dance, 'Rangoli' and such like histrionic activities, revolving around contemporary and relevant social themes. Both public and government schools and NGOs have been competing on the same stage. Besides healthy participation in cocurricular activities, HKF helped evolve our Gen Next into socially responsible citizens. The HKF was initially launched by our Trust in 2008, and thereafter continued as an Annual Feature.



#### 5th Hum Kishore Festival:

The 5th Hum Kishore Festival was held simultaneously at three Centers, namely, St. Columba's School, Lancer's Convent School and the National Centre for Adolescents at Dwarka(UVNAC). FICCI-CASCADE Committee on Anti-Smuggling and Counterfeiting Activities Destroying Economy and Narayana Group of educational institutes joined hands with Urivi Vikram Charitable Trust (UVCT) to organize this magnanimous Festival. The annual festival, which takes up different social themes every year, had this year as "Fight



Smuggling and counterfeiting".105 schools in the Delhi NCR region participated in the festival. The students highlighted the problem of counterfeit and smuggled goods and their impact on the economy through skits, painting competitions, essays and various other competitions. The competitors were given attractive cash prizes, take away gifts and running Trophies in 14 events.

The 5- day long Festival ended with a Grand Finale awards ceremony at FICCI auditorium. The awards ceremony was

chairperson of the Trust, while welcoming the guests said that the trust is functioning in six centers in Delhi and 5 states namely Andhra Pradesh, Bihar, Haryana, Karnataka, and Maharashtra besides in USA. Mrs Bakshi spoke about future plans of the trust and assured that the Trust would work for the society with zeal and dedication. Treasurer UVCT, Mr Negi said that the trust will raise its infrastructure by adding more computers in Ramesh Nagar and Tagore Garden Branches for the students. Prizes were given to the students, who performed on this occasion.

#### **UVCT Policy Planning Meetings:**

Annual General Body meeting: The General Body Meeting of was held at UVNAC Building, Dwarka, New Delhi on 8th September, 2012, in which the Members reviewed the progress of various on-going projects and deliberated on future plans. The AGM noted that there was a deficit of Rs. 5,92,195/- and a liability of an unsecured loan of Rs. 39.00 lakhs in the FY 2011-12 and resolved that all the Members should be trying their best to improve the financial position of the Organization. The AGM amended the Rules and Byelaws of the Trust and widened its objectives with due reference to the Preamble to the Constitution of India, in order to expand its activities for the empowerment of all sections of society. The AGM increased the Membership





charges and Annual Subscription of the Patrons and donors. The AGM also considered the draft Rules and Byelaws for streamlining the working of UVCT Chapters outside Delhi and approved the same. The salient features of these Bye-laws are that all the Chapters would have their own Membership, and elect a Managing Committee. The Head of the Chapters would, however, be a Chairman who would be appointed by the Governing Body of UVCT Parent body in Delhi.

The AGM appreciated the grand success of 5th Hum Kishore Festival and resolved to make it a Brand Festival of the Trust, by holding it annually in the month of April/May when the new academic session starts. The Governing body of the Trust was unanimously re-elected with replacement of Dr. A.K. Singhla, who was away on posting to Arunachal Pradesh, by Shri Muneesh Kapoor. In the AGM,

certain activities have been ear-marked for individual members to act as Conveners and gear up those activities.

Meeting of the Advisory Board:
Advisory body of the Trust is a composite body, comprising subject experts, members from the field of community welfare & development and representatives of our Corporate Associates. The Members reviewed the ongoing programs and the progress made to make the Trust more visible and programs more effective. In this direction, the members suggested the following action which has been accepted and adopted for implementation:

- Focus on core concerns to develop competencies in our fields.
- Stress on systematic documentation of ongoing programs to leverage accrued benefits.
- · Take up Research projects on felt needs.

Governing Body Meetings: The Governing Body held meetings regularly and in total, nine meetings were held during the year. In the absence of Dr. Rao, Chairman and Mrs. U.Chaya Rao, Vice Chair-person, who were abroad for three months, work of the Trust was carried on effectively by other Members of the Executive Committee. The GBM decided to take to Court, if need be, against the Notice received from MCD, North Delhi to vacate the Ramesh Nagar Center. Alongside, it was also decided to find alternative building for shifting the Ramesh Nagar Center, which had been working very well with an average strength of 300 beneficiaries a month. GBM also strongly supported for continuing the HKF as a Brand Festival and bring out a Souvenir, in order to raise funds for holding the Festival in a befitting manner.

#### Other Important Events:

Sadbhavana Divas (Celebrations of Vikrams Birthday): On the occasion of Vikram's birth-day, some of the beneficiaries of UVCT paid floral tribute at his 'Samadhi' in



Green Park. A 3-Day Akhand Path, a tradition set by Vikram's 'grand father' and a Founder Trustee of UVCT Late Sardar Ajit Singh Cheema, was organized at Tagore Garden from 16 to 18" January, 2013. Navshakti Club organized Sports competition. On this occasion, a 'langar' was held and blankets were distributed.

UVCT Organized a dental camp on 12 October at Ramesh nagar centre and on 23 February 2012 at Tagore Garden centre: More than 120 students availed the free dental



treatment. The camp provided free dental health check-up community places. The underlying aim of organizing the dental health camp was to extend the basic dental healthcare services to the families who are otherwise devoid of it and consequently suffer from a range of dental ailments that can be treated easily if provided with basic medical aid. The same kind of camp organized in association with MAIDS (Maulana Azad Institute of Dental Sciences) at Tagore garden centre. A team of expert doctors was appointed for the camp. In addition to free dental health check up, awareness was generated on cleft palate surgery issues. Minor treatment related with dental health was given there and then. A total of almost 80 families availed free health services.

education, hygiene, HIV/AIDS and substance abuse from 20" March 2013 to 23" March 2013. The training was imparted to two school teachers from 100 government schools ie, 200 in number. The Training was Conducted at HOS of District SW-B, District M.P. Hall, Najafgarh. Dr.Ranga, Joint Director, IEC, DSACS gave the HIV/ AIDS scenario in Delhi and how DSACS is working towards the slogan Delhi Bole AIDS nahin. He spoke about the services of DSACS. The key note address was given by the chief guest of the occasion, Project Director DSACS, Mr. Garg who is also DC, West Delhi. He shared some examples and cases he had come across, when he was posted in Tihar Jail.



#### The main objectives of training these Government school teachers were:

- To enhance Life Skill knowledge of teachers to impart the same to the Students of 9<sup>th</sup> to 11<sup>th</sup> Class Students.
  - To impart basic information on nutrition, mental health, substance abuse, gender issues and HIV AIDS.
  - Incorporating measures to Teachers to prevent stigma

and discrimination against PLHAs.

- To sensitize towards the gender issues prevailing in our Society.
- Understanding adolescent's issues and their concerns.
- To make them aware of the impact of substance abuse and its relations to high risk behavior.
- To give basic idea of voluntary blood donations and build future donors and motivators.

NIPCCD Team Visit: 30 participants from all over India from NGOs engaged in planning, implementation and management of programmes visited different Activity Centers of UVCT - Ramesh Nagar on 29.8.2012 to acquaint with the various activities of the Trust, interact with the authorities of UVCT and adopt them at their respective NGO's, as a part of their Training Program organized by NIPCCD. The participants were explained about the Life

Skill Education and different projects of UVCT like Sahara, Parivartan, Ummeed, Shakti and they were all influenced and appreciated the activities.

#### Training of trainers for Government school teachers:

Urivi Vikram Charitable Trust (UVCT) conducted Training of government school teachers on life skill





- To educate the teachers on the importance of communication skills among the adolescents in dealing with their daily life and while facing interviews.
- To sensitize towards making the adolescents self reliant (through linkages to livelihood).
- To make Teachers aware of the importance of careers options for the adolescents in their coming life.

#### Empowering Women by giving them training on Selfdefence

A 10-Day Self-defense course organized from 18th March to 28th March, 2013 in Ramesh Nagar in close collaboration with Delhi Police, Special police unit, Nanakpura. This self defense program was held to wake up the girls and women in fighting against any untoward incident. Shri Subhash Sachdeva, MLA inaugurated the camp when Shri Raj Kumar Lamba, Councilor was also present. The participants were the students of UVCT and children from our Ramesh Nagar



community. The training camp also focused on sharpening women's ability to predict dangers in a safe and practical manner. In order to help women feel empowered and independent on the roads.


# Our other Chapters:

#### **UVCTs global Initiatives:**

Chairman, UVCT and Vice Chairperson visited USA from 25.10.2012 to 9.1.2013 where Chairman inspected the activities of UVCT, USA chapter and formulated plans to further strengthen the activities of USA Chapter.

#### **UVCT Michigan:**

International Academy's Indian American Student's Association (IASA) held its annual cultural program on April 18, 2013 at Troy Athens High School. The Michigan Chapter of Urivi Vikram Charitable Trust partnered with IASA in presenting the well attended event. IASA chose UVCT as one of its designated



charities and donated a part of the proceeds from ticket sales to UVCT. The event was a roaring success with talented students from both campuses of International Academy participating in musical, drama and dance performances. Hirsh Jain, UVCT Michigan Chapter chairperson, spoke about UVCT's unique and honorable mission of empowering underprivileged teens in India and elsewhere. Some of the students who have worked or supported UVCT initiatives have got points and that resulted into their admission in prestigious Howard University. Keeping Hirshs example of getting admission in Howard in view, more junior students at International Academy have displayed a keen interest in joining the Michigan chapter and continuing the work. UVCT Michigan Chapter plans to undertake service activities benefiting underprivileged urban teens from local communities in the coming year.





- 100% beneficiaries were females in Maharashtra.
- Through vocational programs, enhanced skills of 519 young females which resulted in economic improvement of their family members.
- The trust has opened Bank account of over 356 young females as CSR activity of the UVCT-Central Bank of India during May 2012 to March 2013.
- Organized Hemoglobin Testing camps in community nearest Health post or centers over 453 young females



#### Maharashtra Chapter:

The Urivi Vikram Charitable Trust, Maharashtra Chapter, Bhiwandi has trained over 519 young adults during May 2012 to March 2013 for livelihood integrated program of Life skill education. Trainees are prepared to deal effectively with life and challenges through a lively life skill education and various types of vocational training the participants were mentally prepared for work place situation. The program has been running successfully in various community centers in Bhiwandi Slum, Thane district of Maharashtra State. Success of the first and Second Phase of the program has led to its renewal and continuation to the Third Phase till December 2013.

#### Impact Study:

The study was essentially a tracer study undertaken to note the economic and social impact of the training programmes conducted by Urivi Vikram Charitable Trust (UVCT). These training programmes are conducted to impart vocational and life skills to the participants. These participants are females who could be school/college dropouts, from low income groups.

participants are females who could be school/college dropouts, from low income groups.

#### Findings and the conclusion of Economic and social impact of the UVCT training in Bhiwandi, a communally sensitive area of Thane district:

- Majority of the participants belong to the age group of 15 to 25 years, i.e. 126 participants (85% of the students).
- Majority of the batch consisted of students (32%) who are either completing their higher secondary education or graduation. Chart 2 shows different occupational groups that the participants belong to.
- About 68% of the participants have 5 or more members in the family including themselves.





- After training, 38% of the participants have started taking orders/getting clients for beauty treatments, who charge for their services. Most of them have been doing these treatments for their friends or family for free.
- About 54% of the participants have joined this training program because of the Word Of Mouth activities done by their trainers. The rest have heard about it from friends, family or pamphlets.
- On an average, the income of the family of the participants is between Rs. 12000-16000.
- The life skills training module has been rated as 9 (on an average, out of 10) by the participants. The vocational skills provided have been rated as 8 (on an average, out of 10) by the participants.
- About 31% of the income is saved by the participants.
   The rest is spent on household items, other items (for their personal use), medical facilities and education.
- 52% of them have opened a bank account.
- About 46% of the participants save between Rs. 0-500 per month.

After interaction with the participants, we can say that this training has definitely made an economic and social impact on their lives. Getting opportunities to work with small parlours, selling their broaches to small traders, catering for small events in the community, these are some of the initial steps that these girls/women have taken towards economic independence.

They have learnt the importance of savings, hope they continue to save in the future. Most of them have many family members in their houses; these are extra mouths to feed. The additional income earned by these participants after training has helped them to support

expenditure for household items. The girls/women have a changed perception about living after attending sessions on decision-making, goal setting etc. More such programs are need of an hour for economically backward people.

#### Success stories from Maharashtra Chapter



Savita Rasur, Age:, 20 years, living in Devjinagar, Anjurphata. I am just 10th pass and I could not study due to insufficient family income and in our Vadar (Stone broker) community, women

are not allowed to pursue further education. Our family comprised of 5 members is solely surviving on daily wages on my father and my elder brother I always wanted to support my family but was afraid of my father and brother. My mother heard about UVCT's Life skill and vocational training program, Beauty culture in nearby our area. I decided to visit the centre and met project officer. She informed me about the vocational activates and Life skill programs. My mother helped me in getting admission in Beauty culture training program for a nominal fee of Rs.100/. I also took admission in LSE class and Beauty Culture Course. After completion of Beauty Culture Course I got job in private Beauty Parlor getting salary of Rs. 3000/pm besides running a parlor from my own house and earring round Rs.5000/-pm in lean season. I am very thankful to UVCT for giving a chance to grow in life.





Mumtaz Momin, Age 29 years: I have been living in Tandel Mohalla, Idgah Road for more than 14 years. I am just 7th std pass in Urdu language and I could not study due to big family comprised of fourteen members. I got married at 15. I have two

school going sons. My husband was in private job, getting salary of Rs.7000/- pm. After 3 es of beauty culture and two batches of cooking course at a salary of Rs.12000/- pm besides this I am running a parlor from my own house and earring round Rs.5000/-pm in lean season. Now I am very happy and satisfied person. Today I fulfill all the needs of my family. I am very thankful to UVCT for giving a chance to grow in life, and half years of our marriage my husband developed movement problem in his leg. Fifty percent of the income of my husband's earnings goes on the treatments. I was facing lot of problems, as if this was not enough my husband became paralyzed and totally bedridden. I was not getting any support from my in laws or from my own parents. I heard about UVCT's Life skill and vocational training program of Beauty culture in nearby our area. I decided to visit the centre and met project officer. She informed me about the vocational activates and Life skill program. And my mother helped me in getting admission in Beauty culture training program for which the fees was only Rs.100/. Then I also took admission in LSE class and Beauty Culture Course. After completion of Beauty Culture Course I got job in UVCT as a Beauty trainer. Today I am conducting two batches of beauty culture and two batches of cooking course at a salary of Rs.12000/- pm besides this I am running a parlor from my own house and earring round Rs.5000/-pm in lean season. Now I am very happy and satisfied person. Today I fulfill all the needs of my family. I am very thankful to UVCT for giving a chance to grow in life.



Ruksar, age 14, was a child labor. Her mother is doing moti ornament and father is a loom worker in small scale industry. Her parents did not pay much attention to her studies and hence never tried to put her to the school. She

enrolled for Beauty culture program in UVCT. She is also did her Life Skill sessions and this new found confidence enabled her to get enrolment in the National child labor special school in Bhiwandi at shantinagar. Today she has learnt to make Glass painting, jardoshi work, decorative work from raw material and curtains.



Swapnali, age, 21 is a school dropout. She was studying in the Bhatiya Vidyalaya and left school when she was in the VIII standard, the parents also did not pay much attention to her studies and hence never tried to put her back in the school.

Swapnali has five younger sisters; she does her daily household work. Swapnali's mother died two years back due to some health problems, father has no fixe job, and house is on rental bases. The income of the family is very low. Her father was searching for her marriage alliance, but it was difficult due to lack of education. She waited patiently to find her true soul mate. After doing a course with UVCT she has gained a new found confidence to face the world. Today she is earning a decent salary in a beauty parlour.





#### Vishakhapatnam Chapter

During the current financial year UVCT conducted vocational training programs and career counseling programs. Under vocational training programs, the trust conducted trainings for the underprivileged and marginalized sections. The trainings were imparted in Tailoring, Beauty culture, Fabric painting, Candle making and Mehendi training. About 200 women and adolescent girls were trained in different trades.

UVCT organized a two day career counseling program for students on 12th and 13th July 2012, in close

collaboration with Vishakapatnam City Police. The program covered characteristics of adolescence, life skills, study habits/memory techniques, multitude of careers and how to choose an appropriate course of study and career. The chief guest on this occasion was Police commissioner J. Purnachandra Rao, IPS. He ensured his support and commitment for the welfare of the children and advised them to realize the value of time and achieve their goals. Leading 24 experts in various fields participated and gave valuable information to students on various career options. A large number of children from various schools and few junior

colleges participated in the program. UVCT Founder chairmen Dr. UNB Rao, I.P.S and Vice chairperson Smt U.Chaya also participated in the two days seminar, besides social worker and philanthropist Curie Vijay Kumar, Principal of Master Minds, Panduranga Rao, JSS coordinator, David Raju Andhra University. This event was widely covered by The Hindu.





#### **Rural Counseling centre**

The Rural Counseling center (Pragati Patham) established by UVCT in Tekkali Village of Srikakulam district, with the financial support of Ministry of Youth Affiars & Sports, GOI, developed linkages with 12 villages near around, and trained 25 rural counselors. This arrangement succeeded in reaching out to hundreds of students from those villages, especially for motivating them and get aware of multitudes of careers and their modalities. The centre was refurbished with relevant books and career literature, which were found required by beneficiaries to prepare for selection tests in careers popular in that area, such as police, armed forces, clerk grade examination, teacher training and like. This centre served as nodal agency for rural counseling in the surrounding villages, besides being a resource centre for people in Tekkali. Through this, UVCT reached out to 2000 young adults.

#### Haryana Centre:

UVCT provides vocational training to women/ youths in beauty culture & sewing, cutting & tailoring so they can earn a dependable livelihood and finally break the cycle of poverty. This year we have changed the lives of 150 young women by giving them trainings.



#### Kirari Centre

UVCT has started empowering the females by providing them vocational trainings on stitching, embroidery and beauty culture at Inder Enclave, Kirari Village since April, 2012. . Kirari village known as Kirari Suleman Nagarand is inhabited by large number of migrants mainly from Bihar and other places. The Kirari constituency has 4 municipal wards catering to approximately 2.5 lakh populations comprised of 105 blocks (6 colonies). The Bench mark survey conducted by UVCT, as a pre requisite formality for applying for "Support of Training & Employment Programme (STEP) under the scheme of Ministry of Women & Child Development, GOI. It was found that there is an immense need of providing vocational trainings for the said population. Due to dearth of resources we cannot cater to the need and requirement of the community. We are quite hopeful that this year we get some support from Ministry of women and Child under STEP program to further strengthen our work. This year we have been able to train 100 females in stitching, embroidery and beauty culture.

# Future action plan:

The action plan for current year is envisioned to create a safer, secure, sustainable and more equitable future for adolescents, young adults, and women. While some of these programmes will be value addition to the existing projects, others will be new initiatives.

Impact Analysis: Besides continuing with the on-going activities, UVCT proposes to undertake evaluation and impact assessment of Shakti program conducted from 1995 to 2013.

#### Advocacy and building relationships

Besides advocacy with the key decision makers to prioritize the adolescent component in the policies and schemes of the Government Ministries/Departments.

Build relationships, Schools, PSUs, other NGOs, universities, government agencies, and communities— to support UVCTs work and create advocates for adolescent issues.

#### Educational Events/Activities/school based and centre based

- Improve the physical, social, emotional and intellectual needs of adolescents, youths and women by building their capacities, conducting workshops on family values, ethics and integrity, time management, career guidance and continuous comprehensive education (CCE)
- Create a strong pool of Adolescent ambassadors and enlist volunteers for our next Brand festival, Hum kishore/community event
- We will create special activities for parents so they can better encourage their children to make healthy life decisions.
- We will conduct seminars/discussions pertaining to the vulnerabilities of young people face. Discussions will include: sexual abuse, drugs, alcohol and others chemical abuse.
- Celebrating special days like Children's day, Youth day, Brotherhood day, Red Cross day, and Friendship day.
- · Celebrating the brand festival: 'Hum Kishore Festival'.



#### Health

- Besides working on two TI projects in Wazir pur and Narela under overarching guidance of DSACS, we will take care of children of the victims of HIV/AIDS
- We will also share our expertise and experience with the adolescent health clinics which are operational under directorate of health services.
- We also aim to extend our helping hand to promote health of the school children through health education and awareness campaigns; we have already sent a proposal to Delhi directorate of health under Chaha Nehru Sehat Yojna.
- Sensitization programs with colleges to make redribbon clubs and make adolescents aware of the implications of HIV/AIDS.

#### Women Empowerment

- Linking the women who have been trained on vocations to livelihood by providing them counseling, and proper guidance; build the bridges between 'Haves' and 'Have not's.
- Monitoring and evaluation of the work done in the last year and its impact on the community besides women empowerment, children and senior citizens in the area shall also be taken care of.

#### Senior Citizens

- The centre for the senior citizens started in UVCT Tagore Garden, shall be further strengthened by adding yoga and meditation sessions.
- Continuing with intergenerational meets promoting linkages between aged and adolescents.





We, at Urivi Vikram Charitable Trust, proudly recall the visit of Shri Shivraj V. Patil, formerly Union Home Minister on 11<sup>th</sup> March, 2011 when we celebrated the 19<sup>th</sup> Foundation Day. He recalled his long association with the Trust and appreciated that the Trust was addressing the developmental needs of adolescents. He has underlined the need for timely guidance at this very critical stage of human

A gentleman politician, statesman, philosopher and disciplinarian. He practised high standards of ethics and resigned from the office of Union Home Minister owning moral responsibility (a rare quality in Indian politicians) when 29/11 terrorist attack took place in Mumbai. He is presently the Governor of the State of Punjab and Administrator of the Union Territory of Chandigarh.
