An ardent believer in justice and fair play, Vikram had a passionate zeal to usher in a society free of corruption and nepotism. The UVCT mission is to fulfill Vikram's cherished ambitions.



Dear Friends,

Yet another year has passed off. Could we do anything substantial at UVCT! We may have, but such an introspection generally helped us to grow better. Social Service has been our Mission in a bid to 'reverse the arrow of sorrow' that inflicted us 24 years ago. My wife Chaya worries how to make best of what we have in hand while I look around for funding and better opportunities! Thus we have been sustaining UVCT activities continuously, without interruption, all these years with an earnest hope that help would always come forward for good work !

Over the last 23 years, as you are aware, UVCT has been our mission to help empower young people. We have been saying that we cannot bring down our population growth to level zero and that we should strive to transform our growing population into productive assets. We talked, though in our own humble way, that we are to make best use of our 'demographic dividend'. Today Prime Minister Narendra Modiji has rightly picked on this vital issue and envisaging plans for skill up-gradation and optimum utilization of human resource. UVCT feels greatly enthused by such assertions.

During 2013-14, UVCT endeavoured to widen its horizons and launch on bigger projects. We continued to work for making all the funded - projects as 'Activities of Excellence'. These projects included two 'Target Intervention' (TI) programs (HIV/AIDS prevention) at Wazirpur and Narela industrial areas; 'Gender Resource Centre' (GRC) in Kapashera (as one photo-journalist tend to call parts of Kapashera as 'Dharavi' of Delhi, bordering Gurgaon); and the 'Adolescent Development Program' under NPYAD Scheme of MYAS. We may have succeeded to a large extent, but suffered man-power crunch and delays in flow of grants. It is found that there is a greater demand for professionals to work in NGOs whereas such people with commitment for a social cause are dwindling. At recruitment front, aspirants talk more on 'pay packages' and less on their work content or professional competency. NGOs may have to turn into 'social enterprises' to become more competent and productive.

Some of the highlights for the year are: our beloved Dr Karan Singhji visiting UVNAC and cheering us up; much-awaited establishment of an Adolescent Centre for our Corporate Associates in the form of 'BHEL-UVCT Adolescent Centre' in Hyderabad; empanelment of UVCT by the National CSR hub for 'Adolescent Skill Development'; start of Bindapur Centre in place of Rameshnagar Centre; and UVCT getting confirmed of its FCRA Registration after the current close scrutiny of NGOs by the Min. of Home Affairs, GOI. The other important job that we could was working for reforming Children-in-conflict with Law at Majnu-ka-Tila Observation Home, North Delhi. It was a joint effort made with AACCI, at the behest of Delhi High Court. The results have been encouraging that prompted in establishment of the Mental Health Units by the GNCT of Delhi at various Observation and Children Homes.

We could not hold our Brand Festival, 7th Hum Kishore, as scheduled. Many enthusiastic participants and their schools/parents fondly reminded us to carry on this tradition and assured all possible support. As such, we should be holding this Festival of Art and Culture for the adolescents, without fail in the ensuing April-May, 2015.

My wife Chaya joins me in offering our grateful thanks and loving greetings to all our General Body Members and numerous well wishers.

Dear Well Wishers.



The Journey carried to transform Burden of India's population into a National Asset, since 1991

Urivi Vikram Charitable Trust (UVCT) was founded by Dr U .N .B. Rao and his wife, Urivi Chaya in 1991, with the support of a few well-meaning friends /relatives, in fond memory of their only son, Urivi Vikram, who was killed at a prime age of 20/21 years in a road accident. It is a Non-Governmental and non-profit Organization. The Rao family tried to reverse the 'arrow of sorrow' and worked to empower adolescents and young adults, especially from lower S.E.S. UVCT's priority target group comprises drop-outs and under-achievers, besides school going children. UVCT has a motto of finding ways and means to transform the India's 'Burden of Population' into an 'Asset of Human Resources', through a process of empowerment, rather than of control.

Besides its 14 Centres functioning in 6 State chapters and alliance with a number of other organizations and institutions, UVCT expanded its horizons in the global arena with UVCT, USA. In 2013, UVCT started first-ever Adolescent Centre for BHEL, a Corporate Associate, in Hyderabad. Efforts are afoot to get many more Centres started through other Corporate Associates and PSUs.

During the last 22 years, UVCT evolved specific projects catering to the needs of young adults. These projects are basically (i) **Psychological Counseling and Career Guidance (Project Prerna)**; (ii) Harnessing the enormous energies of drop-outs and under-achievers (**Project Shakti**); (iii) Vocational Training and Extending support to find meaningful vocations (**Project Sahara**); (iv) Reformation and rehabilitation of children in conflict with law, through Life Skills Education and Vocational skills (**Project Parivartan**); and (v) Financial assistance to those children who are academically bright, but financially weak (**Project Ummeed**). Program '**Sahara**' is also integrated with program 'Shakti' to ensure linkages to livelihoods.

Alongside, UVCT actively advocates that adolescence is a 'distinct and critical stage' of Human Development and that they should have specific schemes for their nurturing and development in the national framework.

In the year 2007, the Trust built its first ever 'Urivi Vikram National Centre for Adolescents (UVNAC)' in Dwarka, New Delhi-110077. The centre is being used for conducting and promoting in-depth studies and run a number of projects and training/orientation programs for the development and empowerment of young adults.

Our Vision, Mission & Objectives

Our Approach: We care for All, but strive for Adolescents...

The Trust firmly believes that due care must be given to the stage of 'adolescence' (aged between 10 and 19 years), a period of rapid changes and identity crisis in one's growth. At UVCT, we are striving to provide quality counseling services to children and adolescents. Through this, we aim to help the children identify their hidden talents and provide psychological, emotional and mental support to cope up with their daily personal problems. Based on a holistic approach we work to promote an all-round personality by addressing all the stake-holders i.e. adolescents, teachers, principals, parents and relevant communities. Our activities aim at empowering adolescents to improve their coping skills and knowledge so as to become valuable assets and the agents of change for a better tomorrow.

What we stand for?

Our Vision : Transforming Burden of population into an Asset of Human Resources

Our Mission : Finding ways and means to strengthen young adults through empowerment rather than control, and bring into mainstream the drop-outs , under-achievers and children-in- conflict with law, especially from those belonging to marginalized and deprived sections of society.

We aim to help them become socially responsible and economically productive citizens of India and the world.



Objectives:

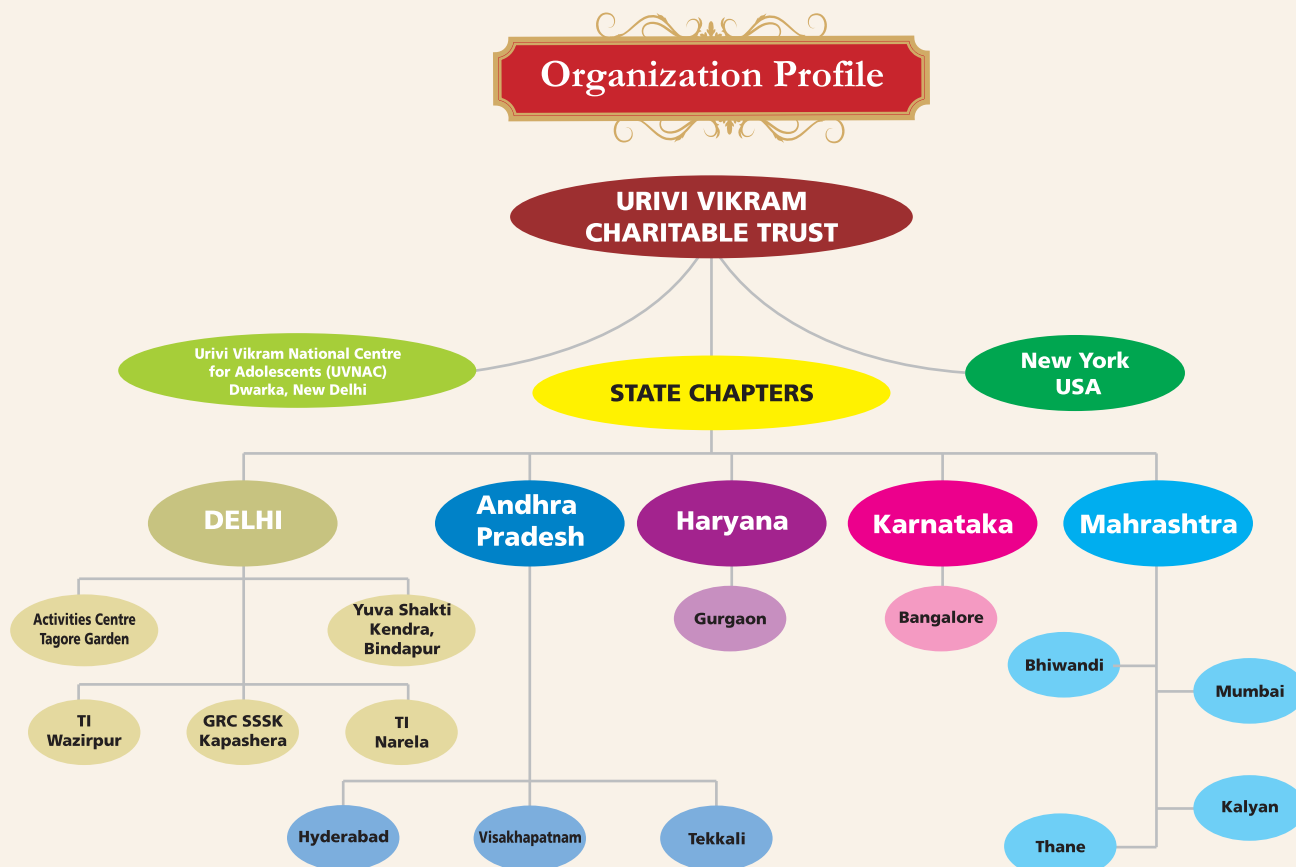
- ❖ Better utilization of India's demographic dividend, resulted due to growing numbers of younger population (Adolescents constitute 22% of India's population: 2011 census).
- ❖ Empowering the Generation next - by providing psychological Counseling/Career Guidance, and extending Life Skills Education, Vocational Skills, and other needed capabilities so that they can find suitable avenues for livelihood and strive for betterment.
- ❖ Helping to develop a confident young India that is unafraid of change and changing social and professional situation - equipped with specialized skills and an ability to learn newer skills and newer methods of working;

- 26th Feb., 2014** : BHEL signing an MOU with the UVCT for setting up an Adolescent Centre in their premises in Hyderabad
- 29th Oct., 2013** : Dr. Karan Singh Ji, visited UVNAC on the 21st Foundation Day of the Trust
- 29th Apr. to 3rd May 2013:** **6th Hum Kishore Festival**, sponsored by BHEL. Hon'ble Minister for Women and Child Development, Smt. Krishna Tirath was the Chief Guest.
- 5th Dec., 2013** : UVCT was assigned by DSACS another TI project in Narela Industrial Zone on HIV/AIDS intervention amongst the migrant community.
- 2nd Nov., 2012** : Opened new **Gender Resource Centre (GRC)** at Kapashera and Samalkha by Smt. Sheila Dikshit, Chief Minister of Delhi.

- 22-24 July, 1999** : **The First National Meet on theme 'Policy for Young Adults'** was held, Shri T.N.Sheshan, former Chief Election Commissioner of India and Dr. Karan Singh, as the Chief Guest. It was attended by 300 young adults, about 80 experts and 40 Govt. representatives.
- 13-14 Feb., 1999** : UVCT's Mumbai Chapter was launched.
- 25th Dec., 1995** : Shakti Children participated in All India Rajiv Gandhi Festival and bagged All India Team championship in Arms Wrestling, were honored by Smt. Sonia Gandhi.
- 3rd October, 1995** : Launch of Project '**Shakti**' to mainstream school drop-outs and under achievers, by Shri Madan Lal Khurana, Chief Minister, GNCT, New Delhi.
- 18th July, 1993** : '**Prerana**' a developmental project on Counseling and Career guidance was launched.
- 12th Dec., 1991** : Urivi Vikram Charitable Trust was established on the first 'Barsi' (death anniversary) of Vikram.

Highlights of 2013-14

Visit of Dr. Karan Singh to UVNAC

H.E. Dr. Karan Singhji, a well renowned and learned stalwart of our country, who has been guiding and supporting the endeavors of UVCT right from its inception in 1992, once again honored us with his gracious presence at its 21st Foundation Day on 29th October, 2013 at the Urvi Vikram National Centre for Adolescents (UVNAC), Dwarka, New Delhi. When UVCT started organizing Career Melas, he led the movement by presiding over the 3rd Career Mela at Air Force Auditorium in 1996; presided over the National Meet held in 1999 that paved a way for a National policy for Adolescents in India; and presided over the next National Meet in 2005 on the theme "Adolescents: Vision 2020". He was the one who encouraged the UVCT to go ahead with establishing the first-ever National Centre for Adolescents by giving a massive grant of Rs 20 lakhs in 2005 under MPLADS. During the visit, Dr Karan Singhji greatly appreciated the theme of the Centre and its adolescent-centric activities. He inspired one and all with his message for empowerment of the young adults.

The scheme of 'Adolescent Ambassadors' was revived and the Chief Guest inducted a total of 26 adolescent students as Ambassadors who are expected to advocate for the welfare and development of adolescents as a distinct group. On this occasion, a Rolling Trophy for

extending the best Civic Services in Dwarka sub-city was also presented to the Dwarka Division of Horticulture, Delhi Development Authority. Shri Angad Singh, the Dy Director received the Honor.



BHEL - UVCT Adolescent Centre, Hyderabad

On 26 February, 2014, Urivi Vikram Charitable Trust signed a Memorandum of Understanding (MoU) with Bharat Heavy Electricals Limited for starting an

promoting Life Skills and to extend Psychological counseling and Career Guidance, and the like. The Adolescent Centre started functioning w.e.f.1st of April, 2014 for a year, with proviso for its extension.

UVCT hopes to develop this Centre as a model Centre and thereby, emulate elsewhere. Its annual outlay is for about Rs. 9 lakh, out of which UVCT receives only 10% as administrative costs for selection, placement, training and hand-holding of the locally recruited staff. A local Management Committee oversees its functioning.



Adolescent Centre in BHEL Township, Ramachandrapuram, Hyderabad. The MoU was signed in New Delhi between Dr. U.N.B.Rao, IPS (Retd.), Founder Chairman of UVCT and Shri K.M. Lakshminarayan, GM(HR), BHEL, Hyderabad. The Centre is first of its kind established by the UVCT for a Public Sector Undertaking as a project under their Corporate Social Responsibility. Its avowed objectives have been to empower adolescents and young adults living in and around the BHEL campus, by conducting out-reach programs; interacting with Principals/Teachers/Parents to appraise them about adolescent concerns and to guide them how they could at best help them to be productive and socially responsible citizens; conducting in-house programs for

Bindapur Centre in place of Ramesh Nagar Centre

UVCT was intrigued by a direction from the Municipal



Corporation of Delhi to vacate the premises of Ramesh Nagar, on a plea that the premises were required for yet another more important community activity. Some rulings of the higher courts were cited, which lacked clarity. All possible efforts were made to persuade the local elected representatives and the Municipal authorities, but in vain. Even the beneficiaries of the



various activities of the Trust (about 300 young adults and women were getting benefited through life skill programs and various vocational programs which have had good linkages with livelihoods) sought to stage public protest rallies. But UVCT opted to avoid a confrontational approach and looked around for an alternative venue. In appreciation of the committed endeavors of the Trust, Delhi Urban Shelter Improvement Board (DUSIB) made available, on the recommendations of the then local MLA, Shri Mukesh Sharma, a Basti Vikas Kendra in SRS Pocket-4, Bindapur, a rur-urban colony of Uttamnagar constituency in West Delhi. In these premises, a new centre for vocational skill training, life skill education and career guidance was started on 31st August, 2013, which was inaugurated by Shri Mukesh Sharma, the then M.L.A. and Parliamentary Secretary to former Chief Minister, Delhi. Around 1000 persons participated in the event. Besides the services of counseling and career guidance, the Centre has training facilities for dress designing, beauty culture, computer education and spoken English, besides life skill education and craftworks. The newly organized

Centre is gaining popularity in the area through its renewed efforts.

EMPANELMENT OF UVCT AT National CSR HUB, TISS, Mumbai

UVCT was empanelled by the National CSR Hub, established by the Ministry of Heavy Industry, in Tata Institute of Social Sciences (TISS), Mumbai, vide Hub Code No. B/1/12/11/226 in the areas of Adolescents - Skill Development for the areas of New Delhi, Andhra Pradesh and Maharashtra up to year ending March, 2017.

- ❖ Over 1.6 lakh young adults have gained skill and confidence to change their lives.
- ❖ Counseling and career guidance programmes have reached out to approximately 30,000 persons.
- ❖ 7500 youngsters covering government and private schools received individual counseling and career guidance services.
- ❖ 350 Parents and Teachers were addressed.
- ❖ Trainings to 100 young adults under National Program for Youth and Adolescent Development (NPYAD)-Ministry of Youth Affairs and Sports.



The three landmark programs of the UVCT aims at empowering the participants and link them to livelihoods. The concepts of 'Prerana' (psychological counseling and career guidance) form the base, especially for school-going children, while 'Shakti' focuses on Life Skills education for out-of-school adolescents. After having provided the adolescents with the needed mental make-up, and the life skills to move forward (especially for drop-outs and under-achievers), Project 'Sahara' (vocational training and placement services) helped them to a road of self-employment and /or get into possible job avenues. Some of the beneficiaries even opted to improve their studies and look for better avenues.

In-House Counseling & Orientation programs

The fully equipped Counseling and Career Guidance Centre (CGC), which was established in 2007 at Urivi Vikram National Centre for Adolescents (UVNAC), Dwarka, continued to extend services mainly to students and young adults. Similar services were made available by the experts of UVNAC, on weekly basis, in Tagore Garden, Bindapur and Kapashera Centres. The CGC is equipped with psychometric tests, relevant manuals, Career and psychological pamphlets and other technical aids. As many as 750 adolescents from both government (free of cost) and public schools (nominal fees), and beneficiaries of UVCT Centres received individual counseling services. Students having special needs with

concerns, identified during outreach programs, were specially invited and given the facility. In about 350 cases, parents/teachers also participated in the interactive workshops. The topics covered were:

- ❖ Confidence Building and Public Speaking.
- ❖ Interpersonal Relations and Problem Solving.
- ❖ Time Management, Study Habits and Techniques to Improve Memory.
- ❖ Communication Skills, Presentation Skills and Building a Positive Personality.
- ❖ Self Grooming and Confidence to become Leader.
- ❖ Reproductive Health, Child Health & Personal Hygiene.
- ❖ Preparation for Examinations and Time Management.
- ❖ Social Media and its implications on studies.

For Parents & Teachers

- ❖ Handling emotions of children and coping with their high risk behaviors.
- ❖ Know your growing child and how to help them choosing a right career.
- ❖ Examination blues and role of parents.
- ❖ Inter-generational perceptions and how to arrive at a common ground.
- ❖ Linking elderly with adolescents

National Program for Youth and Adolescent Development (NPYAD) Scheme, Ministry of Youth Affairs and Sports, GOI

UVCT has been running this project across four states since 2011. During the year 2013-2014 the project performed extremely well and the achievements were very satisfactory. Under the program a series of outreach activities were organized in different states, namely, Delhi, Haryana, Andhra Pradesh and Karnataka.

Notably, the Rural Counseling that was started in UVCT Centre, Court Street, Tekkali-532201, Srikakulam District received a good response. It was unknown concept

and, thereby, had some initial problems. The counseling Centre is named "Pragati Patham", which literally means 'Road to Progress'. The Centre functions as counseling cell along with library to provide career guidance to the students. The Centre is looked over by a team comprising of a counselor, a regular librarian and an assistant. During the last year, over 500 rural students and their teachers/parents were directly benefitted by the rural counseling Centre.

The Career Mela held in Visakhapatnam was also an unusual success. Though it was originally planned for the school students, a number of graduate engineers were found job-less and looked for appropriate guidance. As such, a special session was organized for them with Dr S. Vijayakumar, CMD of Vijay Nirman, a well-reputed Engineering Concern, LEADING THE FORUM. About 80 well-qualified, but un-employed young men and women took advantage of the session'

Principals' Meet

A Principals' Meet was held in UVNAC Building on 29th July, 2013 from 10.00 a.m. to 3.00 p.m. on the theme 'Adolescent Students in Government Schools and Improving their Performance' and covered issues such as characteristics of adolescent students; how to build their self-esteem and yearning for knowledge in rural children; how to prevent violence in the schools and in how teachers could help students in making appropriate career choices. The Principals' meet became a grand success and as many as 37 Principals/Vice Principals attended the program. Shri S.K.Gaur, SPE, South-West District, representing the Director of Education led the Principals and ably initiated the discussions. All the participants actively interacted and shared their views, which became basis for further discussions with the Experts.

UVCT Activity Centres in Delhi

Rameshnagar, West Delhi The Activity Centre which remained fully functional for over a decade and made a difference in the lives of more than 10,000 young adults and women from Kirtinagar, Chunabatti, Subash Nagar and other neighboring areas had to be closed down by end August 2013, as stated earlier, on the directions of Municipal Corporation of Delhi, ostensibly for them to start a Recreational Centre for old age residents. Within those first 5 months, it trained more than 580

beneficiaries, including students that came up for summer training.

Bindapur, South West Delhi In the newly established Centre at Bindapur, which started functioning in September, 2013, UVCT undertook a detailed assessment of the needs and potentials of the area. The popular vocational courses such as dress designing, beauty culture and Computers attracted about 230 students during the 6-month period. Self Help Groups (SHGs) were formed. Several meetings were held with the Anganwari workers to gain a better understanding of their lives and work. A series of lectures on Life Skill Education were given at the Nasha Mukti Kendra. Guidance and career counseling facilities were extended for students of the neighborhood schools.

Tagore Garden Extensions: The Centre which has also been in operation for over a decade suffered some environmental problems, especially due to a licensed Liquor Vend that operated in the ground floor of the market. Shri P L Sehgal, a veteran social worker who organized the Ramesh Nagar Centre till its closure, took over Tagore Garden Centre and made a few structural changes. With the help of the market association and the local police, the activities of the liquor vend and its customers were checked. A ten day self-defense



workshop was got organized with the help of Delhi police for women of the neighborhood. These moves effectively contributed for revival of the Centre, taking the strength of its beneficiaries to more than 300 per day from the earlier level of 100. A number of Mohalla meetings were held to improve the reach of the local

persons. During the 6-month period, the Centre extended programs for about 680 beneficiaries, in Life Skills, Vocational skills(Computer education, Beauty culture, Typing and secretarial practices, dress designing and textile based handicrafts such as cushion-making, hand embroidery, soft toys, etc).

UVCT Best Worker, 2013-14



Shri P L Sehgal, a graduate from Delhi University (1988) superannuated as Senior Stenographer from the Delhi School of Social Work in 1999 after having served for 35years.He joined UVCT in July 2004, as an instructor

in Secretarial practice and soon thereafter, rose to the level of Program Coordinator and Officer in charge of Ramesh Nagar Centre and since took over Tagore Garden Centre. Even at an age of 75, he is energetic and hard-working, with a sense of dedication and service to the humanity. He is meticulous and innovative, and thereby proved an asset to the establishment of the UVCT. He is unanimously adjudged as the Best worker of UVCT for the Year 2013 -14.

General Evaluation of beneficiaries of Delhi Centres:

Majority of our beneficiaries were from migrant communities, from the neighboring states. Trainees from Uttar Pradesh, Bihar and Rajasthan comprise around 55% of the total number of the beneficiaries, with Punjab contributing to around 7%. Another 19% students belonged to the migrants from far-flung states including North East states and even Nepal. Majority of the students came with 6th-12th standard of education. While majority of them (59%) were in study and came here to further supplement to their qualification, there were a sizeable section among them who were school drop outs. Among the trainees, around 21% were

under-graduates, who were in search of employment. UVCT's programs are designed in a way so as to make them prepared either to secure gainful jobs or start their own enterprises.

UVCT's objective to empower adolescents and young adults (82%) from the marginalized and weaker sections (90%) with competence and marketable skill so that they feel confident to make a stable and sustainable livelihood, was well fulfilled. In the year 2013-2014 the Centres had got students from all social groups cutting across castes, ethnicity and religions. A graphic analysis of the beneficiaries is given below:

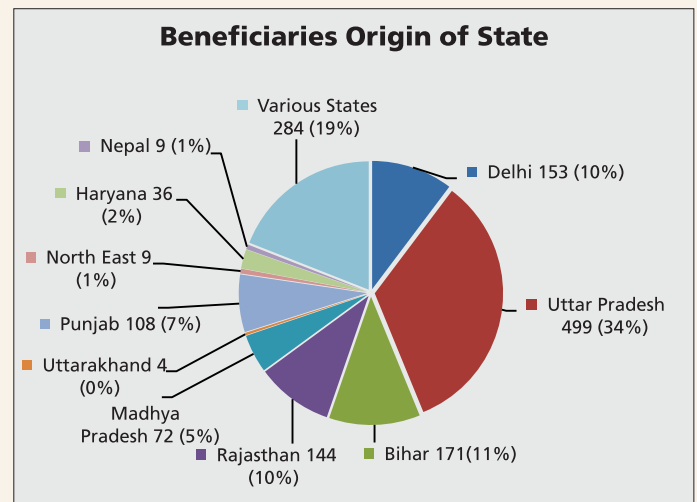

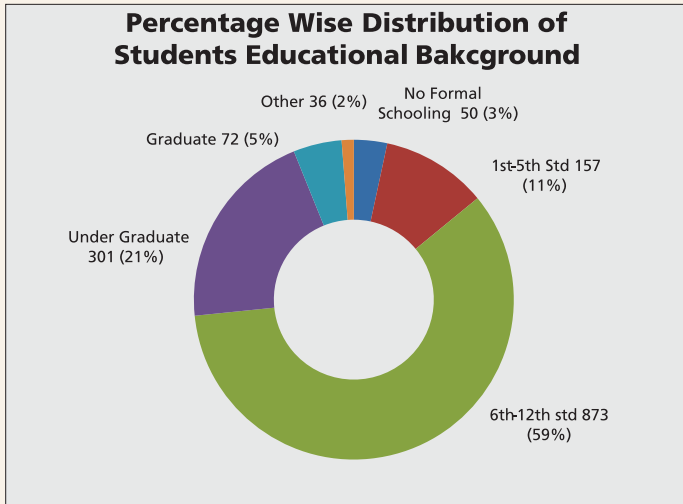

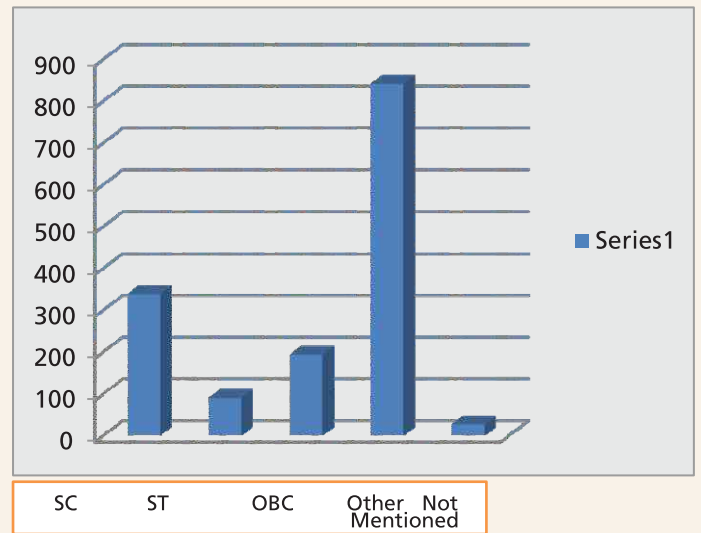

TRAINING ON WOMEN SAFETY

A Self-defense Work-shop, in collaboration with Special Police Unit of Delhi Police for Women and Children, was organized from 8th to 17th July, 2013 for women at UVCT, Tagore Garden Centre. More than 75 girls and



women participated. After Nirbhaya's brutal killing, it became all the more necessary for all the Institutions to make women of the society aware of the invisible danger to their life and dignity by obnoxious elements present in the society.



IGNOU Study Centre Activities

The IGNOU Study Centre located in UVNAC has gained tremendous popularity during the last four years. The student strength of the Centre rose from less than 100 in 2000(at the time of inception) to 959 by 2013-14. The Centre offers both graduation and post graduation courses , namely, Bachelor in Social Work and B.A. (Psychology) ; and M.A. (Psychology); Masters in Counseling and Family Therapy; and Masters in Social Work; besides a Certificate Course in Guidance. During 2013-14, as many as 390 M.A. (Psy.) students (both First and Second Year and 205 MSW students attend their respective classes. The convergence between UVNAC and IGNOU helped in not only help improving educational qualifications and extending practical training facilities at the various Centre s of the UVCT. The centre has drawn a number of house-wives and professionals in promoting their educational qualifications. It is heartening to see many students seeking to change their Study Centre s from elsewhere to IGNOU SC-38013 at UVCT.



AACCI - UVCT PROJECT FOR CHILDREN IN CONFLICT WITH LAW (C-I-LS)

Delhi High Court Juvenile Justice Committee kindly accepted the proposal of AACCI (Association of Adolescent and Child Care in India) and UVCT team to conduct some anger management programs in the "Place of Safety" and Special Home located at Majnu Ka Tila (MKT), North Delhi. UVCT team focused in extending Life Skills Education and some Counseling services.. The UVCT Chairman Dr. U.N.B. Rao, IPS (Retd.) visited the MKT complex and introduced the MKT staff to the Life Skills Education on the basis of a Power Point Presentation. The MKT staff varied in their perceptions as to how they should be dealing with the inmates, while majority of them maintained that inmates' misbehavior was mainly because they had 'no fear of punishment'. They, however, accepted that the inmates should be understood in a friendly manner and that they should be 'kept busy'. One important finding is that the reasons for Juvenile Delinquency, as per the MKT staff, are family

problems and bad friends (90%), while it is low on 'No fear of punishment' (20%). But in case of reasons for misbehavior in Observation Homes, same MKT staff (as many as 80%), are of the opinion that a lack of 'fear of punishment' is the main cause. In other words, the juveniles may have taken to crime for various reasons but once they were in the Observation Homes, their misbehavior was mostly due to a lack of 'fear of punishment'. It leads to the belief that existing statutes and living atmosphere in the Observation Homes might be making the juveniles behave differently from how they were prior to their arrival there. UVCT staff visited both the Special Home and Place of Safety thrice a week and imparted Life Skills Education to the inmates, by using the under-mentioned modules of the Life Skills.

It was an interesting experience and the inmates seemed to have appreciated the concepts of life skills and yearned to continue with them. Alongside, AACCI concentrated on profiling and counseling of the inmates.

- ❖ **Out-reach Programs:** 4 out-reach programs were conducted in different high schools of Visakhapatnam. A large number of boys and girls participated in these programmes.
- ❖ **Parent Meets:** The parents meets were held on

29th November and 6th December, with the objective of creating awareness among parents about the psychological issues faced by both parents



and children and finding solutions to the problems. Nearly 35 parents participated in the events. Ms. Roopa Veni, lecturer in Psychology, Vishakha Women's College functioned as resource person.

- ❖ **Life Skills Education:** The UVCT Visakha chapter conducted two life skills programs, at Community

Hall, Gandhi Nagar, and the UVCT office premises. In the former a batch comprised of 20 boys of 12- 15 years. In the latter 23 students participated. They all were under achievers.

- ❖ **Rural Counseling:** Counseling has been provided to 12 students in office premises, in Viswa Joythi Junior College. Nearly 250 students were covered. In Goligonda of Visakhapatnam district, a career orientation class for APRSW Junior college & high school students was conducted. A total of 500 students were covered.



- ❖ **Vocational Training:** The UVCT Visakha chapter provided vocational training programs for women. The programs included Tailoring, Fabric Painting, Art work, Beautician. 500 participants benefited from these courses. A legal aid counseling cell was also inaugurated in the UVCT premises, The Project Co-ordinator Smt. Saraswathi & Career Counselor Mr. Naresh were the key facilitators.

UVCT: GURGAON

Yuva Shakti Kendra was started in Gurgaon for the empowerment of adolescents and women of the area. The Centre was inaugurated on 30th August, 2013 by Smt. Sunita Kataria, Municipal Councilor. Programs were held in Beauty Culture, Life Skills Education, Embroidery, Spoken English, and Mehendi. A few out reach programs were also conducted in neighboring schools/colleges under NPYAD scheme.

Career Mela

One-day Career Counseling Program was conducted on 27th December, 2013 in Visakha Public Library, with the objective of creating awareness among the students, especially, of the government schools / colleges on various career avenues and also to guide them in choosing their career. Nearly 250 students from different schools and colleges participated.

The program was attended by Hon'ble Deputy Commissioner of Police Ms. Samuchi Bajpai, Chairman of UVCT Dr.U.N.B.Rao, Vice-chairman of UVCT Sri Atul Rathi and Secretary of POWER NGO, Sri Abdul Raqueeb.

The topics discussed were life skills, new & emerging careers, subordinate services and careers in banking & insurance. In the evening a program was conducted to orient students for competitive exams. The participants found the program very useful and wanted such mela to be held at regular intervals. The Chairman and other dignitaries appreciated the efforts of the Project Co-ordinator and Career Counsellor.



UVCT'S efforts for STEP program in Anandpuram

UVCT, in association with 'POWER' (People's Organization for Welfare in Rural Environment), a local organization formulated 'STEP' (Support for Training and Employment Program), The Min. of Women and Child Development, GOI, for promoting sustainable employment for women through improved horticulture techniques including Organic Farming in Anandapuram Mandal, Visakhapatnam District, Andhra Pradesh. Anandapuram, a rural mandal of Visakhapatnam, is traditionally known for cultivation of vegetables and flowers. Due to lack of irrigational facilities, the farmers in the area depend on vegetable and flower cultivation, in which endeavor the women folks play a major role. Additionally, enhanced prices for lands adversely affected the production of vegetables in the surrounding areas,



which led to a pressure on Anandapuram Mandal for increasing its production by hook or crook. It has come to notice that Anandapuram Mandal has become the highest user of pesticides in the entire area. In other words, the vegetable produce of Anandapuram was

In this regard, top management of UVCT, along with horticultural experts such as Prof B.B.Sharma, former Head, Horticulture department, IARI, thoroughly studied local conditions and prepared a detailed proposal. It was recommended by the district authorities, but remained for long with the Women and Child Development department of Govt. of Andhra Pradesh. Once the proposal is recommended and forwarded to the Govt. of India, a final decision shall be taken by the latter.

UVCT: Maharashtra

Altogether 9 Programs of Beauty Culture, 22 sessions of Life Skill Education and Women Empowerment were organised by the Bhiwandi Centre. It extended its activities to Kalyan area as well. Some of the notable programs conducted during the year are as follows:

I. One-day orientation program on Adolescent Reproductive and Sexual Health was held for the women in Kacheripada, Bhiwandi in October, 2013. Dr. Mokashi, Head- In charge, IGM Hospital, Bhiwandi was the facilitator.

II. LSE in Municipal School: A survey was conducted in 11 municipal schools to assess the students' perceptions about life skill education. Majority among the respondents showed interest in LSE sessions. The LSE programme was started in a Municipal school, near Kacheripada.

III. Essay competition and Prize Distribution Program was organized for NSS students at BNN

College, Bhiwandi: An essay competition on "Advantages and Disadvantages of Technology towards Developments" was organized for the NSS students at BNN college on December 10th, 2013. The prize distribution ceremony was held on 18th January, 2014. A guest lecture on technology by Resource Person Ms. Sharayu M. Phadke, Research Assistant, TISS, Deonar was also organized.

IV. To explore area approach for Project intervention in Kalyan- Dombivali Municipal Corporation (KDMC), For the purpose of starting a new batch of vocational training and LSE, UVCT began exploring the area in Kalyan-Dombivali Municipal Corporation (KDMC) from January 2014. After developing a rapport with the community leaders, a house-to-house survey was conducted in several slum areas, like Gurga Chawl, Anandnagar slum, for locating the out-of-school/college drop-outs and youth population. The programme received excellent response from the students in slums.

So, I took admission in Bag Making Course and used all my old clothes and started making bags using mirror, dori, jhoomar etc. After completion of the course, our teacher Mrs. Krishna took me to Sadar Market and Paharganj Market and bought me sufficient material to start a shop. I started my own shop of Fancy Bags and earn sufficient money and happy to see women roaming with bags made by me. I am grateful to GRC and Krishna Madam in particular.



My name is Kiran Devi and I am a member of Payal Self Help Group. I have three children and including me and my husband, it is a five member family. My husband could not get regular job and it was difficult to run the family affairs. I took loan from my SHG and started a vendor shop making pakoda, tea etc. in my hut itself. My husband also started helping me in my works, whenever free. I am now able to earn our bread and butter and very proud of shouldering all responsibilities. I have also started tuition for my children. After repaying the loan, I wish to start my regular shop of pakoda and namkeen etc. I am grateful to GRC-SSSK for making my life smoother.

Success Stories from Other Centres



Mrs. Harshda Jadhav,
Age 22. Married

I am a school drop-out and living in Bhiwandi urban slum area. I am 8th pass and got married at the age of 16 years. Due to insufficient family income and customary restrictions in the Kunbi community, I could not pursue further education. I have two small children. In our big family including in-laws, my husband is the only working person. He is in private job and getting salary of Rs.8000/- pm.

With an aim to support my family, I decided to learn 'beauty culture'. I was afraid of my parents-in-law who were a bit conservative. At that time, I learnt from a neighbor about UVCT's Life Skill (LSE) and training program on Beauty Culture and joined. Then I also took admission in LSE class in spite of doing all household works. After completion of the Course, I have opened a beauty parlor in our house. I am hard working and pick up things fast. I apply the knowledge of life skills that I have gained during training in my day-to-day life to keep me happy and satisfied. Later, I got job in a private Beauty Parlor on a salary of Rs.5000/- pm. Besides running a parlor of my own, now I have a guaranteed earning of Rs.5000/-pm in lean season. Seeing financial gain, my in-laws have extended full support. I have opened a saving account in the Central Bank at Mandai branch in Bhiwandi. I keep saying that UVCT is my lucky charm and I am very thankful to UVCT for giving a chance to grow in life.



Mujbulla Ansari, Age 29.
Married

I have been living in Tandel Mohalla, Idgah Road for more than 31 years. I am just 7th pass in Urdu language and I could not study was big family consisting of fourteen members and insufficient family income. I got married at the age of 18 years. I have two school going sons. My private job has no fixed salary. After 4 years of marriage, I become a chain smoker, spending more than half of the income on this. I was already facing difficulties of low income and then because of this habit, the situation went from bad to worse. I was undecided and did not know how to get out of the situation.

That was when I heard about UVCT's Life Skill Education program and Plumbing training. The trainers in the nearby UVCT centre motivated me to take admission and the fees was only Rs.300/- for three months. During The LSE sessions on de-addiction, Parmeshwar sir explained about ill-effects of smoking on our body and mind, as well as its impacts on one's economic and social situation. I started feeling bad about my smoking habit and finally I quit it. It gave me courage to motivate other people in my contact to leave smoking. After completion of the Course, I got a plumber's job in the building construction site where UVCT took us on exposure program. Now I am getting salary of Rs.10000/-pm. I am very happy and mentally satisfied. I am in a position to fulfill the needs of my family. I am very thankful to UVCT for helping me change my life.



Shahin Heena Ansari,
Age 19

I am a school dropout. I was studying in the Urdu medium school and left school when I was in the V standard. My parents did not pay much attention to my studies and hence did not put me back in the school. I have six younger sisters and I have to do daily household works. My mother has been sick since the last two years and father is a power loom worker. We live in a rental house. The income of the family is very low.

I was desperately searching for job, but was not making any breakthrough due to lack of education. Incidentally, I came in contact with the personnel of the UVCT vocational training centre wherein I was persuaded to undergo the Beauty Culture program and Cooking Course. I enjoyed the beauty culture and cooking classes. In spite of the challenges and barriers, I completed the course. Later I took admission in the informal education to fulfill my dreams.

After completion of the Beauty Culture and Cooking courses, I have started my own food court in the market area with services of snacks in the morning hours and in the afternoon. I am busy in the beauty parlor running from home. I make an earning of around Rs.9000/-pm even in lean season. I have opened a saving account in the Central Bank at Mandai branch in Bhiwandi. I am very thankful to UVCT for transforming my way of living.

OTHER INITIATIVES of UVCT in Delhi

TIs at NARELA & WAZIRPUR Industrial Belts

HIV/AIDS is extensively prevalent in India. While no permanent cure has been discovered yet, the preventive measures play vital role in controlling the spread of this deadly epidemic. For prevention, it is important to identify not only the infected individuals but also the areas where the incident of HIV/AIDS is maximum. Various studies reveal that migrant laborers and truck drivers are most affected by this. Under the auspices of Delhi State Aids Control Society (DSACS), UVCT has been organising two Targeted Intervention programs in Narela and Wazirpur Industrial Areas, situated in Outer and the North West Districts of Delhi.

With the help of various support units (one of them TSU, positioned by DSACS), UVCT TI teams followed a holistic



UVCT- TI assisted the community in acquiring (1) Adhaar cards, (2) RSBY cards and (3) Voter-IDs. Life skill classes were organized for the children. Shramik Shiksha Board was engaged to conduct 2-day workshops for migrant men & women (Topics covered - Health and Hygiene, Importance of Education, HIV/AIDS awareness). Registration of potential HIV/AIDS infected individuals and counseling was successfully carried out at the DICs. Health camps were organized and operated as per the

approach as per the guidelines of NACO. Besides awareness & sensitization of community, there is identification of HRG(High Risk Group), stipulated service delivery, and rendering advice regarding prevention methods including usage of condoms, ICTC testing, treatment of infected and care of PLHA. The primary assessment informs that out of 13000 HRGs, 11211 (90.75%) are males and 2233(10.25%) are females. It has been found that 50% HRGs are between the age group of 20-30 years.

In this year, the emphasis was given on all round improvement of the affected community. In this different activities under the project, such as Health Camps, STI Identification and Treatment, ICTC testing, Group Sessions by ORWs and Peer Leaders, Mid Media Activities and DIC services were integrated under one strategic goal. This enhanced involvement of community in the program.



guidelines of NACO - in identified areas and at DICs. UVCT-TIs organized Nukkad Nataks on the theme of HIV/AIDS issues. More than 5350 community people saw these Nukkad Nataks. The audience was encouraged to ask questions related to HIV/AIDS issues which were addressed by the TI project team. These events proved to be popular and effective in facilitating awareness and enhancing awareness and curiosity in the community.

The TI Centre s supplemented their assigned tasks, with extending Life Skill Education to the adolescents of the targeted area, which were received quite enthusiastically. The beneficiaries are as given below:

Gender Resource Centre

Urivi Vikram Charitable Trust started a Stree Shakti Suvidha Kendra (Gender Resource Centre) at Kapashera, South-west Delhi. It is an area at the border of Delhi with Gurgaon, and houses large number of migrant population in distressing conditions. A pocket of Kapasera is considered by media circles as 'Dharavi of Delhi'. Skill Training: Empowering young people with employability skill.

Life Skill Education, Counseling and Career Guidance: Introducing life skill education programmes in government and private schools. Organising Career Melas in schools with a focus on emerging skill demands.

Collaboration/Partnership with Governments:

Women Empowerment: Replication of GRC programme models in various UVCT centres across the states.

Mobilise young women into groups and raise awareness on safety and security.

Youth Friendly Services: Involving more schools in Hum Kishore Festival and introducing events that meet today's needs.

Issue Based Interventions: Collaborating with government to implement schemes for youth and adolescent development.

Joint Venture with Corporate Social Responsibility:

The Trust will forge partnership with Corporate Sectors and work on Health, Education and Livelihood issues. In this connection it will take special initiatives to develop programme-based relations with various Public Sector Undertakings, Industrial establishments and the academic centres managed by corporate. Identification of new courses based on corporate interactions to promote livelihood programs with the aim of providing placements of trainees for semi-skilled jobs.

Advocacy on Emerging Adolescent Concerns:

"National and regional level seminars/workshops to mainstream adolescent issues in the development agenda.

"Promote pro-active interactions and dialogue between senior citizens and young adults to co-create solution to mutual strains struggles.

"Evolve action plans to involve young adults in governments' nation building activities.

"Promoting forums of students and young adults and raise awareness on HIV/AIDS.

Professional Service and Technical Supports:

UVCT has an inter-disciplinary team of technical experts. Its team of professionals comes with huge grassroots experience and from diverse streams of expertise. UVCT's technical services are available in the area of monitoring, research and evaluation. The experts of UVCT are available for facilitating training for development managers.





GOVERNING BODY MEETINGS:

Six Governing Body meetings were held on 25th May; 27th July; 18th August; 12th October; 19th January; and 22nd February, wherein the members of Governing Body reviewed the progress of activities and deliberated on important issues such as, holding of 6th Hum Kishore Festival, Publication of Souvenir, Vacation of Ramesh Nagar Centre, CSR activities, Celebration of Foundation Day, activation of Bhiwandi in Thane district, fund raising from Corporations like NBCC, GAIL etc., Opening a Centre in Rewari, Opening of BHEL Centre at Hyderabad etc. The business transactions and financial status of UVCT were also reviewed.

Dr. Karan Singh's Association With UVCT

Karan Singh is a member of India's Upper House of Parliament, the Rajya Sabha, and a senior member of the Indian National Congress Party. He has been the

Chairman of the Indian Council of Cultural Relations. He is a well-regarded statesman and an orator.

Born on March 9, 1931, in Cannes, France, to Hari Singh, the last ruler of the princely state of Kashmir and Jammu, and his wife Tara Devi, he was educated at the Doon School, Dehra Dun, and received a B.A. from Sri Pratap College, Srinagar, and both an M.A. in Political Science and a Ph.D. from Delhi University.

He Served successively as Regent, first and last Sadr-i-Riyasat and Governor of the State of Jammu and Kashmir from 1965 to 1967. In 1967, he resigned as Governor of Jammu and Kashmir, and became the youngest-ever Member of the Union Cabinet, holding the portfolios of Tourism and Civil Aviation.

In 1979, he became Minister of Education and Culture as part of Charan Singh's cabinet. In 1989-1990, he served as Indian Ambassador to the US; he chronicled this experience in a book titled, "Brief Sojourn." He received the Padma Vibhushan in 2005.

Dr. Singh has been guiding and supporting the endeavours of UVCT right from its inception in 1992. When UVCT started organizing Career Melas, he led the movement by presiding over the 3rd Career Mela at Air Force Auditorium in 1996; presided over the National Meet held in 1999 that paved a way for a National policy for Adolescents in India; and presided over the next National Meet in 2005 on the theme " Adolescents: Vision 2020".

He was the one who encouraged the UVCT to go ahead with establishing the first-ever National Centre for Adolescents by giving a massive grant of Rs 20 lakhs in 2005 under MPLADS. He once again honoured UVCT with his gracious presence at its 21st Foundation Day on 29th October, 2013 at the Urivi Vikram National Centre for Adolescents (UVNAC), Dwarka, New Delhi.
