A young man with great enthusiasm, novel thoughts and a wide vision, Vikram met with a fatal accident when he was almost 21. An ardent believer in justice and fair play, Vikram had a passionate zeal to usher in a society free of corruption and nepotism. The UVCT mission is to fulfuil Vikram's cherished ambitions.

# Dear Friends,

The year 2014-15 witnessed significant progress in the activities of UVCT and this has further strengthened our resolve to work towards the upliftment of adolescents. Our endevours in our Maharastra Chapter won appreciation and due recognition. Three years ago, we had received a grant of Rs 2 lakh for women development in Bhiwandi area of Maharashtra from the Central Bank of India. This grant was raised to Rs 5 lakh in the subsequent year and the results have been so impressive that the IDBI Bank Ltd, in the current year, gave us a sumptuous grant of Rs 15 lakh for the



empowerment of both women and adolescent students in Bhiwandi-Kalyan-Thane area. Alongside, the IDBI Capital Market Ltd also extended a grant of Rs 14.5 lakh for conducting a Comprehensive Training Programme for 500 young people in Delhi to function in Marketing and Financial Services. Both these programmes have done extremely well, reaffirming our faith that funds would flow in automatically if good constructive work is done. It has been a heartening experience to receive a grant of Rs 2.5 lakh from Sohan Lal Commodity Management Pvt. Ltd. for providing training in Handicrafts in one of our Delhi Centres. We hope the Government of India's directives for CSR funding to NGOs would give further fillip to well-meaning voluntary agencies working in the field.

However, the Gender Resource Centre in Kapasehra, Delhi, and the Target Intervention Centres in Narela and Wazirpur Industrial areas - funded by the GNCT of Delhi - had to bear the brunt of inordinate delays in the release of funds. Both these programmes, especially the one in Kapasehra, are an excellent model for convergence of efforts to extend all-needed services to the marginalized segment of society in Delhi. With just a budget layout of about Rs 20 crore, about 130 such Gender Resource Centres are presently functioning in Delhi.

The continued support from the Ministry of Youth Affairs and Sports, Government of India, under their National Programme for Youth and Adolescents Development (NPYAD), helped us to make a mark in our Rural Counselling Programme in the Tekkali area of Srikakulam District, which had been a Naxalist-prone area (in the 1970s). The "Pragati Patham" (a Library cum Resource Centre), established therein is making a difference in the lives of a number of young people who would have otherwise gone astray. UVCT hopes to get additional support from the Andhra Bank for widening the sphere of activities in this area.

Efforts are underway for launching our new programme "Model to Reform and Rehabilitate Children in Conflict-with Law who are Discharged or on Bail"; a well-needed, but a neglected area, for mainstreaming the young delinquents. Yet another project in the offing is to link "Adolescents with the Senior citizens", both of whom look for emotional support.

Its past 10 years since my retirement from the Police Service (reaching 70 years of age). This Charitable Trust and the goals we have set for ourselves, have given us an impetus to keep moving forward and serve as our reason to live for the cause. My wife, Chaya, who doubles up as the financial controller at the Trust, saves the Trust from avoidable expenditures. Our Advisers and some fifty odd Members are a great support for the Trust. We believe in "Vasudevaka Kutumbhakam" and wish well for one and all.

# **About Urivi Vikram Charitable Trust**

Urivi Vikram Charitable Trust or UVCT is a nongovernmental and non-profit organization that was established in the year 1991 by Dr UNB Rao and his wife, Ms Urivi Chaya, with the support of few well-wishers. UVCT was founded in the fond memory of Dr Rao's only son, Mr Urivi Vikram, who lost his life at the prime age of 20-21 years, in a fatal road accident in Delhi. The Rao family tried to change this blow of destiny that had hit the family unexpectedly by working for the empowerment of adolescents and young adults, especially children from the socially economic weaker section of the society. UVCT has been working for this mission for the last 24 years, with the priority target group of young people comprising drop-outs and under achievers, besides school-going children. UVCT has a motto and feels responsible for finding ways and means to transform India's what may be called "Burden of Population" into an "Asset of Human Resources", through a process of empowerment, rather than control. A thematic framework of various UVCT projects undertaken in this regard is mentioned in the following pages of the Report.

#### **Our Network**

Besides its 14 Centres functioning in six states of India and alliance with a number of other organizations and institutions, UVCT expanded its horizons in the global arena by setting up UVCT-USA. In 2013, UVCT started the first-ever Adolescent Centre for BHEL, a corporate associate, in Hyderabad. Efforts are underway to set up many more Centres that could be started with other corporate associates and PSUs.

#### The Vision of UVCT

With a growing population, India continues to be an effervescent vessel brimming with fresh ideas and ambitions. UVCT has undertaken as its mission to find ways and means to transform this ever-growing population of India or this "Burden of Population" into an "Asset of Human Resources" and thereby, help in ensuring better utilization of India's demographic dividend.

#### **Mission**

UVCT has been striving to work for the development of adolescents and young adults. It believes in strengthening the young adults of the nation through "empowerment" rather than "control", and bringing into mainstream drop-outs, under-achievers, and children in conflict with law, especially those belonging to marginalized and deprived sections of society. It is UVCT's mission to help these children to become socially responsible and economically productive citizens of India and the world.

#### **Objectives**

- O Develop awareness through seminars, group discussions, and camps to help young adults find solutions to their problems-psychological, financial, ethical and social;
- Help acquire a realistic value system that is conducive to the development of a healthy society and to develop the concept of oneness of all religions and love for the homeland in the youth, by raising the level of consciousness;
- Develop educational and skill training programmes for school drop-outs and under-achievers, to enable them to become not only economically productive but also socially responsible citizens of India and the world;
- Develop counselling centres for the disturbed youths; and to establish rehabilitation centres for juvenile delinquents to provide both emotional support and skill training;
- Develop skills among the young adults including women, in regard to textiles, handicrafts and other ancillary industries; and
- Endeavour to promote equality of status and opportunity, assuring dignity of individual and unity and integrity of the nation; teaching basic hygiene, ensuring good health and happiness for all the citizens of India.

#### **Advocacy**

UVCT actively advocates that adolescence is a "distinct and critical stage" of human development and the mission of UVCT is to have specific schemes, in a more coordinated manner in the national framework for the nurturing and development of adolescents. UVCT undertook a pioneering advocacy campaign, with several other NGOs and government organizations, for appropriate development of the adolescent population in the country. Its initiative came at a time, to be realistic, when very little had been done on the adolescent agenda. To overcome this lacuna, a National Consultation was held in 1999 on the theme "Towards a Policy for Young Adults". The Meet resulted in the compilation of an Advocacy document for a "National Policy for Young Adults", which was submitted to the Government of India and the Planning Commission of India. Based on this document, the Planning Commission of India constituted the first-ever Working Group, including UVCT as a member, which duly brought out a "Report on Adolescents" (2001). In continuation of this initiative, UVCT organized a Regional Seminar in 2002 on "National Policy on Adolescents". It resulted in the first exclusive Scheme of Financial Assistance for Development and Empowerment of Adolescents, in April 2014, with the Ministry of Youth Affairs and Sports


as the nodal agency [unfortunately, the Scheme lost its identity and got subsumed into an omnibus "National Programme for Youth and Adolescent Development" (NPYAD)]. However, UVCT's relentless persuasion and campaign culminated in a joint action by the government agencies and the private organizations in holding the second National Meet in 2005 on "Adolescents: Vision 2020", in a bid to identify the demand-supply gaps. Various government, bilateral, and donor agencies have since eventually incorporated adolescent concerns in their policies and programmes for further development.

#### **UVNAC**



#### The Year 2014-15

The year 2014-15 saw many developments for the UVCT with regard to the development of adolescents. The organization celebrated its Foundation Day in November 2014 and the occasion was graced by the Chief of Delhi Police, Shri Bhim Sain Bassi. The year also witnessed unrelenting support from the banking sector of India to work towards the mission of empowering adolescents including women. Major highlights of the year have been indicated as follows:

#### Visit of Shri Bhim Sain Bassi, IPS, Chief of Delhi Police

Shri Bhim Sain Bassi, Commissioner of Police, Delhi, known for his integrity and innovative policing, along with his wife, Smt Sunira Bassi, visited Urivi Vikram National Centre for Adolescents (UVNAC) at Sector 22, Dwarka, New Delhi, on 23rd November, 2014 to attend



the 22nd Foundation Day celebrations of the organization. The function was attended by both

functionaries of UVCT and prominent residents of Dwarka sub-city, besides a large number of beneficiaries from other UVCT Centres in Delhi.

On the occasion, Shri Bassi, recalling his early education at the Government School of Tagore Garden, (where one

of the UVCT Activity Centres is presently located), encouraged children to accomplish their goals in life through appropriate focus and hard work. Promoting free registration of crime and responsive policing, the Commissioner also had a brief interaction with the local residents. He also released UVCT's *Annual Report for 2013-14*, and presented the "Best Civic Authority Award" of the UVCT to Shri DP Singh, Chief Engineer (Civil), DDA, Dwarka, for his innovative and effective measures to mitigate the long-persisting water crisis in the Dwarka sub-city. Shri Bassi also felicitated Shri PL Sehgal, with the "Best Worker Award of the Year". Shri Sehgal, who is 75 years old, is credited for reviving the UVCT Tagore Garden Centre and extending valuable services to the UVCT for over 11 years.

#### **Support from the Banking Sector**

The Banking Sector of India munificently joined hands with UVCT to work towards the mission of empowering the adolescents including women. Banks, such as IDBI and IDBI Capital, funded two important projects, namely, the Livelihood Programme for Women and Youth in Thane district, Maharashtra and the Comprehensive Skill Development Programme in Delhi, respectively. Canara Bank supported UVCT with computers and short-term vocational courses at the Tagore Garden Activity Centre and also at Bindapur, and a library in Tagore Garden, New Delhi. Andhra Bank donated seven computers for students learning computers at the Bindapur Centre and extended training for organizing self-help groups (SHGs).

# IDBI-UVCT Livelihood Programme for Women and Youth, Thane, Maharastra

Thane is the most populated district of not only Maharashtra but also in the whole of India. It is the third-most industrialized district of Maharashtra. Alongside the district, a number of slum pockets exist in and around the industrial zones. UVCT has been functioning in the Thane-Bhiwandi-Kalyan belt of Maharashtra since 1998. It has carried out a number of programmes for adolescents (aged between 10 and 19 years) and women in the fields of skill training, life skills and linkages to livelihoods, counselling and career guidance. In 2011-12, UVCT carried out a livelihood generation project in Bhiwandi slums under the CSR scheme of the Central Bank of India. In this programme, UVCT has successfully reached 766 persons, i.e., almost four times more than the target of 200, wherein majority of the beneficiaries

were from conservative Muslim community. An impact study conducted reported that the outcome was impressive and worth emulating.

In appreciation of the outcome, IDBI Bank sanctioned an



amount of Rs 15 lakh to organize livelihood programmes for women and youth. The programme envisages empowering about 5,000 school-going adolescents and plans to extend personalized counselling and career guidance services to the needy (about 300), to promote their thinking and social skills and thereby, help improve their focus on studies and ultimately find appropriate avenues for living. Additionally, the relevant teachers and parents are given needed inputs through 20 workshops in order to empower them in shaping up their wards as not only economically productive but also socially responsible citizens. Alongside, UVCT is also promoting the employability of 75 educated, but unemployed men/women in Bhiwandi and Kalyan slums, by giving them Life Skill Education, conducting aptitude



assessment and equipping them with Spoken English, computer awareness and other employable skills. UVCT also aims to help them in job placement. In the same targeted slum areas, 600 illiterate and semi-literate women (some willing and needy men shall also be given



opportunity as per local conditions) will be equipped with vocational skills (e.g, beauty culture, dress-making, cooking, jewellery-making, cushion and soft toys- making, candles- and detergent-making, electric repairs, plumbing and the like) so that they could augment their family income through self employment doing possible job works. Efforts are also underway for forming self-help groups and link them with bank loans. In this regard, vocational courses shall be conducted within the slums/living spaces of these people for improving their accessibility. The programme was formally launched on 18th January 2015.

Mr RV Iyer, Chief General Manager, IDBI Bank, and Mr Raja Shekhar, DGM-CDSM, IDBI Bank, graced the Valedictory function and inaugurated the Bhiwandi and Kalyan Office on 23rd March 2015.

# IDBI-UVCT Comprehensive Skill Development Training Programme in Delhi

The IDBI Capital Market Services sponsored, under their CSR initiative, a "Six Week Comprehensive Skill Development Training Programme", with the aim of preparing candidates for employment with Banks and Non-Banking Financial Companies (NBFCs). The programme is conceived and being executed by Shri Anil Girotra, former Executive Director of Andhra Bank. Shri DC Jain, Managing Director & CEO, IDBI Capital Market



Services Limited, came all the way from Mumbai to inaugurate the programme in the Tagore Garden Activity Centre on 11th March 2015. His kind presence enhanced the value of the course.

The programme is a package to meet the current market demands and empower youth who are economically backward to compete with the students of elite class. The basic contents of the Course have been:



- Computer Tally ERP9
- Banking and Financial Services Products
- Filing of E-returns of Income Tax and other related work at ACA's office
- Call Centre Inputs for Banking Financial Services
- Sales and Marketing of Financial Products
- Personality Development through Life Skills and Spoken English and Hindi

While this programme costs about Rs 25, 000 in the open market, the same is offered at a nominal cost of Rs 600 to the beneficiaries. All possible assistance for the placement of the trainee is also included therein.

The programme received enthusiastic participation from the relevant sections of young adults. With the successful launch of this programme in the Tagore Garden centre, UVCT's Bindapur Centre was also set ready to start the same from April 2015. It is hoped that a student passing out of this course would not only be competent in the subject of banking and non-banking financial services but also would grow as an empowered person ready to face the challenges in life with confidence .



#### **BHEL-UVCT Adolescent Centre, Hyderabad**

The BHEL-UVCT Adolescent Centre, which was established after a MoU was signed with the BHEL on 26th February, 2014 started functioning on 1st April, 2014. Initially, it was set up in a Government School and



subsequently was moved to the premises of Jyoti Vidyalaya School in BHEL Township, Ramachandrapuram, Hyderabad. The concept of Adolescent Centre is designed to cater to holistic development of an adolescent by not only taking care of them but also taking into consideration their support systems like parents, teachers, and principals. Despite the fact that the concept of "Adolescence" and the related issues are less known, the activities of the Centre augured well, covering not only the residents of BHEL Township but also of numerous other institutions and communities located far and wide. The Project team succeeded in fulfilling the targets and in some cases, such as outreach programms and workshops for teachers/parents accomplished 50 per cent more than what was envisaged. Requests started pouring in as the activities of the Centre came to the notice of the relevant stakeholders. The Life Skill Programmes and Counselling sessions conducted in Residential Schools of Telangana Government won their appreciation, which subsequently resulted in the ongoing efforts to get three such Adolescent Centres established in three districts of the Telangana state (Details of the same are mentioned in subsequent pages)

#### Rural Counselling, Tekkali, Andhra Pradesh

"Pragati Padham" (Road to Progress), which was established by the UVCT three years ago in Tekkali, a one-time Naxal prone town of Srikakulam District of Andhra Pradesh for promoting counselling and career guidance in the rural area received appreciation and financial

support from the Ministry of Youth Affairs and Sports (MYAS), Government of India. Tekkali is one the backward areas of Andhra Pradesh and lacked developmental programmes. The youth population is large, but the standard of education and employment avenues for them remained far from satisfactory. Interestingly, a few of the local residents including the Founder Chairman of the UVCT, reached higher levels, suggestive of their inner strengths. As such, it was felt that proper counselling and career guidance would evolve the local

students into productive citizens. "Pragati Padham" is a step in that direction.

As part of the "Rural Counselling" component of NPYAD (National Programme of Youth and Adolescent



Development) Scheme of the MYAS, the activities of the "Pragati Padham" geared up. The Chairman of UVCT himself visited Tekkali and had a meeting with the Principals / Heads of Schools and Junior Colleges located in and around Tekkali and ascertained the specific requirements of the local students and their faculty to do better in their studies and career-planning. About 35 rural counsellors were enlisted, who were oriented by the UVCT expert team, and guided from time to time.




### **UVCT Activity Centres in Delhi**

#### **Tagore Garden Activity Centre**


The Activity Centre at Tagore Garden, under the leadership of Mr PL Sehgal, further flourished during the financial year 2014-15. Nearly 850 students were given vocational skills in Typing, stenography, computer application including tally, beauty culture, and dressmaking. Additionally, specific courses in handicrafts, softtoys, bag and jewellery making, etc., were conducted benefitting nearly 120 young adults and women.

#### **Category to which the Beneficiaries Belong**




UVCT has never discriminated against any student on the basis of caste or class, and it can be clearly seen from the above data that almost half of the students belong to the SC, ST, and other marginalized backward groups. 22 per cent belong to the SC group, 14 per cent belong to OBC, but only 9 per cent belong to the ST group. This could be attributed to the fact that Delhi has very little ST population. However, compared to previous years, this year, the percentage of ST students was noted to be the highest.

#### **Education Level of the Beneficiaries**




# **Current Educational Status of Beneficiaries In Each Course**






From the above data, we can say that the aim of empowering under-achievers and school drop-outs has been well- achieved. Students who have studied till VI-XII std or those who are still in school but are not academically brilliant have mostly enrolled for the vocational courses, and by their own admittance, have found a new zeal for life, and to do something for their families. Most of the school drop-outs are pursuing computer, dress-making, and beauty culture classes, while those who are still in school are pursuing Vocational Studies along with Computer, Spoken English, and Typing classes.

#### **State of Origin of Beneficiaries**




#### **Total Family Members of Beneficiaries**




From the above data it may be seen that 40per cent of the beneficiaries have family members between 6 and 10 numbers, followed by 3 to 6 members at 33 per cent. This could be mainly the reason for enrolling themselves in these vocational classes in order to help their families financially as early as possible.

From the above data it may be seen that 42 per cent of the beneficiaries are between the ages of 17 and 19. Most of the beneficiaries are young women and girls, who could not complete their studies, and are pursuing Vocational courses in order to financially assist their families as well as to lead strong, independent lives. Also, the adolescent age group is mostly enrolled in Beauty Culture, Computer, and Typing Classes.

The library sponsored by the Canara Bank is well utilized by the children of Tagore Garden. Books related to academics, competitive exams, general knowledge, and newspapers are also kept, besides providing facilities for internet as well.

The "Comprehensive Skill Development Programme" that was inaugurated in the Tagore Garden Activity Centre has so far succeeded in training 30 students in Computer Tally ERP9, Banking and Financial Services Products, Filing of E-returns of Income Tax, and other related work at ACA's office, Call Centre Inputs for Banking Financial Services, Sales and Marketing of Financial Products, Personality Development through Life Skills and Spoken English and Hindi. Nearly 60 per cent of the students who have passed out have also been linked with livelihood opportunities.

Rekha Dhasade, MSW, is an alumni of Bharti University, Pune, Maharashtra. She joined UVCT in 2012 as a Project Officer. Her extraordinary dedication in the field, has brought many CSR projects to the UVCT's Maharashtra Chapter. Apart from her hard work,

she is known for her innovation and networking skills. She is undoubtedly a valuable asset to UVCT. In appreciation of her contribution, UVCT unanimously adjudged Rekha Dhasade as the "Best Worker of the Year 2014-15".



#### **Bindapur Activity Centre**

The Bindapur Centre of UVCT was established in the year 2013. It has done remarkably well in the year 2014–2015. The centre has undertaken detailed assessment of the needs and potentials of the local area and started various classes depending upon the needs of the community.

Nearly 255 young people were benefitted through various vocational training programmes like Tailoring and Stitching, Beauty Culture, Spoken English and Computer. Many short-term trainings like bag-making, handicrafts, etc., were conducted through the year with the support of Canara Bank.

#### **Other Outreach Activities**

National Programme for Youth and Adolescent Development (NPYAD) Scheme, Ministry of Youth Affairs and Sports, Government of India

NPYAD is one of the important projects successfully

implemented since 2014. Through this project, the UVCT has succeeded in reaching nearly 2 lakh direct and indirect beneficiaries. During the year 2014-15, needs of around 12,000 beneficiaries were addressed through Life Skill Education, Parents/Teachers workshops, outreach programmes in schools, Counselling and Career Guidance, Rural Counselling and Career Melas.

#### **Career Melas under NPYAD**

Career melas are organized to make the students and parents aware about choices and make a proper selection of respective careers. The objective of a Career Mela is to provide information about new and emerging careers in India, to facilitate and inform students about various





career options, and how to proceed (entrance exams, eligibility criteria for various careers), and to help students by removing misconceptions associated with various careers.

A notable Career Mela was organized in Delhi

(64th in the series of the Career Melas) on 10th February, 2015 in collaboration with Andhra Educational Society in Dr Durgabai Deshmukh Memorial Senior Secondary School. Nearly 500 students and 43 teachers participated in the Mela. Need based 11 careers were shortlisted such as engineering, hospitality and hotel industry, judicial







and legal services, NDA and allied, Teaching and allied research, and UPSC (IAS, IPS and allied.). Experts from each field spoke on the specific career which was followed by question and answer sessions where the doubts of the students were clarified. The stalls displaying the material were also adorned with charts,

literature, books, and pamphlets pertaining to various careers. The informative sessions succeeded in giving a greater impact on young minds about the available and workable career options as well as information on new and emerging career choices.

# Other Projects of UVCT in Delhi

# Target Interventions (TI) at Wazirpur and Narela Industrial Belts

Target Intervention Centres of UVCT, Wazirpur and Narela are located in North-West and outer districts of Delhi. Both the areas are mainly recognized for their migrant population, mostly living away from their families, from different states and thus, constitute high risk group (HRG). Activities like identification and registration of HRGs, condom promotions, outreach programmes, ICTC services, health camps and awareness programmes like street theatres were conducted to reach out to the target population. The Centre in Narela seized to function in the month of December 2014.

#### **Gender Resource Centre**

The Gender Resource Centre (GRC) functioning from September 2012 continues to take care of all dimensions related to women empowerment in a holistic manner, and serves as an instrument to bring social, economic, and legal empowerment of women particularly those belonging to the underprivileged sections of Kapashera, South-West Delhi.

The activities of Gender Resource Centre encompasses social empowerment, Legal Rights, Economic Initiatives comprising skill-building, Micro enterprise and entrepreneurship development, health aspects, information sharing and networking aspects, and nonformal functional literacy and women empowerment.

GRC also suffered shortage of funds as it was not released at appropriate times but the committed GRC team in Kapashera never compromised on the quality of the programmes and achieved their set targets. Many dharnas and rallies were held to draw the attention of the Delhi Government for expediting the release of funds but all went in vain.

#### **Problems faced by TI Centres**

There was continuous delay in the release of funds from DSACS during this year. UVCT, despite the shortage of funds, tried to carry out the project activities from its own resources. To keep the motivation of staff alive, UVCT also paid salaries to the staff. UVCT didn't want the

programme to suffer due to non-availability of funds from DSACS. Care was taken to fulfill the targets. Wazirpur fared well even after the shortcoming of funds and achieved the set targets but the evaluation conducted in Narela, showed unsatisfactory results so the Management Committee of UVCT decided to close down the Centre in January 2015.

(A Facility for Counselling, Career Guidance, and Personality Development)

In continuation with the MoU signed with BHEL on 26th February 2014, the BHEL-UVCT Adolescent Centre was set up in the premises of Jyoti Vidyalaya School in BHEL Township, Ramachandrapuram, Hyderabad.

#### **Activities of BHEL-UVCT Adolescent Centre**

**a. Principals' Meet:** Principals' Meet are meant to have a dialogue, at the expert level, with the Heads of various educational institutions and other stakeholders to appraise them about the proposed activities of the Centre and also to be aware of the local needs / constraints of the young people. In total, two meets were held first on 28 May 2014 and the second on 28 November 2014 in which 23 and 17 principals participated respectively from different schools.

#### b. Psychological Counselling and Career Guidance:

Psychological counselling helps resolve a broad range of individual and social problems. Adolescents and parents / teachers look for help when faced with difficult situations such as study habits of students, resolving fears and anxiety, peer pressure, choosing careers, finding root maps for different career, crises in relationship, breaking through depression, or other form of sadness. Individual, supportive, Personcentered, directive and career counselling approaches were adopted depending on the needs of the counselee.



#### c. Outreach Programmes in Schools and Colleges:

An expert team from the centre visits institutions on request and interacts with teachers and students on adolescent-centric issues in a bid to improve their performance. The need to address the issues of children is the demand of the hour. We have taken a



holistic approach to address and strengthen the core of adolescent's issue. For this we have chosen schools as platforms to interact with the group of adolescents (through outreach programmes) and have been able to address many of their issues and helped them in dealing with their problems.

d. Shakti-Life Skills for Personality Development: A 25-day programme of batches having 25-30 participants, especially for drop-outs/under-achievers/ trouble-makers who lack direction in life



were held. It is a socio-psychological programme to build on their strengths and link them to livelihoods. It is a widely acclaimed programme by the UN and has been tried out at different Centers.

**e. Workshops for Parents:** A half/full-day interactive sessions were conducted to help parents "know their



growing children", guide them in career choice and to deal with their high risk behaviours. The objective of this programme was to educate about adolescent issues, its consequences and how to deal with these problems in a pro-active way. Supportive counselling has been provided to resolve their day-to-day problems of parents with adolescents and also four parenting styles and its implications on adolescents have been explained.

**f. Workshop for Teachers:** Teacher workshops facilitated teachers to learn skills, develop ideas and build positive relations with co-workers as well as



with the students. The activities conducted in the workshops focussed specifically on adolescent issues, Teachers' attitudes towards self, family, students, and management with co-workers and to their respected Schools.. It was also to gently sensitize teachers about different learning styles, Multiple Intelligence and to understand the uniqueness of individual students.

g. Career Melas: Career Melas were organized to help Government and Private High School/Junior college students to make informed decisions for career planning and analyse their interests, values, skills, strengths, and weakness.

It was a huge learning opportunity for the students as well as parents. Many prominent speakers /experts came from various fields and addressed the students / parents. Information was provided to the participants on more than 10 new emerging careers along with traditional careers. The whole workshop was carried out in participatory approach.

#### Visakhapatnam Chapter

The following activities were conducted under the supervision of the young and vibrant team at Tekkali and Visakhapatnam:

#### **Outreach Programmes**

The UVCT-Visakha Chapter conducted four outreach programmes, namely, in Government High School in Kancharapalem with 50 students; Mother English



Medium School with 50 students, Port High School Madhavadara with 30 students, and KDPM High School with 50 students. The Outreach programme was conducted for Classes 8-10 on psychological counselling.

#### **Individual Counselling**

In Tekkali, as part of rural counselling, individual counselling services was provided to 30 students on career aspects and also on psychological aspects of behaviour. The issues were discussed and motivation levels of the students were targeted for better outcomes.

#### **Youth Festival**

The UVCT participated in a District Level Youth Festival. It was organized by the NehruYuva Kendra Sangathan on 31st December 2014 in Anakapalli. Representatives of the UVCT stall distributed career pamphlets and also conducted career counselling. Around 150 students have been sensitized under the services.

#### **Neighbourhood Youth Parliament**

The aim of the Neighbourhood Youth Parliament was to:

- create an institutional platform right up to the village level;
- develop platform of youth clubs further in the shape of vibrant 'neighbourhood youth parliament';
- share experiences and ideas; debating on various issues concerning the society and youth; and
- strengthen and enhance the already existing network of Youth Clubs and Mahila Mandals.

This programme was supported by NYK at Anandapuram, MDO office premises. It supports issues pertaining to Jandhan Yojana Scheme, Nirmal Bharat Abhiyaan-Individual Sanitation, Swachh Bharat, Sukanya Samruddhi Yojana, Health, Education, Environment, and Cleanliness actively.

#### **Voter Awareness Campaign**

This programme was conducted by the Nehru Yuva Kendra in Anandapuram area. Sri Subbarajulu Garu, Deputy Collector, attended the session as the Chief Guest. This programme was conducted to increase the levels of awareness about voting and its uses and on how to vote during polling.





#### **Career Mela**

The Urivi Vikram Charitable Trust, Visakhapatnam Chapter, had conducted a one-day Career Counselling Programme on 22nd December, 2014 in the Visakha Public Library, Visakhapatnam, with support from Andhra Bank & the Rotary Club of Hill View. The main objective of the programme was to create awareness among the students, especially government school/college students on various career avenues, and also to guide them in choosing their careers. Nearly 250 students from different schools and colleges participated in it.

Our Chairman, Dr UNB Rao and the Zonal Manager of Vishakapatnam, Shri Lalit Prasad attended the occasion. Sri Prasad was the chief guest at the occasion. Dr S Vijay Kumar, Chairman and Managing Director, Vijay Nirmaan Company, was the guest of honour. Shri Simhachalam Garu, Senior Manager (HR), Andhra Bank, Visakhapatnam, and Shri Bala Bhaskar from I-Focus also attended the sessions.





### **Maharashtra Chapter**

Apart from vocational, and life skill trainings, a comprehensive livelihood programme for women and youth at Kalyan-Dombiwali, Bhiwandi and Thane slum pockets; and subsequent inauguration of the Kalyan office were the highlights of the year.

Banking and finance had always fascinated me, but due to financial and other restrictions, I was unable to join these

courses. I came to know about UVCT's initiative for the youth to make them financially independent through Life Skills Training from my friends. Having done my 12th from Humanities, I was surprised to know that even I could do these courses. Soon after, I joined the Comprehensive Skill Development Programme for Banking and Finance in UVCT, Tagore Garden. I got my desired opportunity to learn about Banking and Finance and Tally along with Spoken English and Life Skill Education. Slowly and gradually, I became confident and my personality has now changed from that of an ordinary being to that of a smart professional. I am thankful to Urivi Vikram Charitable Trust for transforming my life. After the successful completion of the course I am now placed in a reputed CA Firm for hands-on training.



#### **Bhawana Sharma**

Dressmaker with a zeal to continue studies.

I joined Urivi Vikram Charitable Trust when my father once visited the organization in a function in December to organize a *Hawan* at the Centre. I was interested in pursuing the stitching course. I came to know about

the details of the course from my father who suggested me to join the course as it suits my interests. After joining the course I spoke to my teachers and the guides and shared my views about the skill development course. I learned Dress-making and stitching. I wanted to work as a professional dressmaker so I learned and developed creative skills to design dresses and also learnt of cutting patterns. After completing my course, I have started stitching as a profession to earn money. Now I have many customers and doing a reasonable good business through stitching. The money is being used to continue with my studies.



#### **Anupa Mandal**

A home-maker turned independent contributor to family finances.

I hail from Bihar and belong to a Self-Help Group (SHG). I have three children. My husband did not have a very good job and we used to often fight regarding this. Our

financial condition started becoming worse, and this had illeffects on my children. One day, a friend of mine told me about

GRC. She was herself a part of SHG. She took me to an SHG meeting and made me meet a mobilizer who gave me all the required information. I made SHG with 15 other women and met with the mobilizer. We started our work after that. Seven months after, I took a loan of Rs 3,000 and bought a sewing machine which became a mode of my income. Today I earn Rs 500 per day. I can contribute towards the education of my children and provide them with good living standards. I am extremely thankful to GRC which helped me and taught me that anyone can help themselves, even when no other would, if they set their heart and mind on it.



#### Sita Devi

From being helpless and ignorant to being strong and knowledgeable.

I am from Patna, Bihar. I have studied till 10th class and could not continue my studies as my mother was sick and I had to look after her. I have been married for 10 years. I have

two children and my husband works as a security guard. He does not earn much and whatever he does wastes all of it on alcohol. He used to beat me after getting drunk. I got to know about the GRC in Kapasheda where numerous vocational courses for women are taught. I thought of taking up a course in cutting-tailoring. After I got there, I came to know about the various schemes of the Government also, like setting up of an OPD from time-to-time, legal-aid, pension scheme, Ladli Yojana, etc. I completed my cutting-tailoring course from UVCT. Now, I work from home and take care of my children. I am very grateful to GRC. It is because of them that I am now strong and independent.



#### Nisha

From being a 12th pass student to becoming a successful Tally and English-speaking trainer.

I completed my 12th from Science background and wanted to sit for AIPMT (All India Pre Medical Test). But my parents

wanted me to do B.Tech. However, I convinced convinced my parents for AIPMT and dropped one year. I believed in upgrading the knowledge and wanted to utilize the year I dropped. I did not have a good command over Spoken English though writing anything in English was not a difficult task for me. With the regular Career melas being organized by UVCT, I came to know about IDBI Capital Market Comprehensive Skill Courses and found it very effective, wholesome and within the reach of my budget. After completing the IDBI course, I joined the same centre (Bindapur) from where I completed my course, as an English speaking and Tally trainer.



#### **Farheem**

From being disabled to being 'differently-abled'.

I am from Uttar Pradesh.My father runs a small shop and I left school a few months back due to financial crisis to help my father. I failed in Class 11th exam and left the school

due to constant bullying of my classmates for my physical debility. I started helping my father in the shop but later stopped going to the shop too. Once, I visited the UVCT centre and asked about the courses available and found that the charges were very nominal as compared to other institutes. I took admission to a Computer basic course initially and then joined Spoken English course also. Life skill with Spoken English helped me in building my confidence. Now I don't consider myself as disabled but instead I know I am differently-abled and have my own skill sets.



#### Nooka Rahman

A school dropout turned financial contributor of family.

I am 23 years old, married, and living in Visakhapatnam, Arilova area. I am a school dropout. I left school when I was in 7th class. My husband is an auto driver and I have two

children. Since my husband is an auto driver it was very difficult for us to meet the basic needs for living. Then, I heard of the tailoring classes offered by UVCT. I went and joined the course for tailoring. I realized the fee charged was very low and affordable. It is been over a year now that I have been with UVCT, learning all the different techniques in tailoring. Now, I earn up to Rs 4,000 per month alone. I am happy for earning and being able to save my family from financial crisis.



#### **P Mangamma**

An example that early-marriage and illiteracy are not hindrances to earning.

I am 32 years old, married, I did not study. I come from a very poor family. Both my parents were daily wage laborers. Hence, they did not force me to study. I was

married off at an early age. We have a daughter who is studying 8th class in a private school. It was difficult for us to manage with the little amount that my husband earned as we do not have a own house to live in. Every month-end, we were finding it very difficult to manage and ended up in taking debts. I came to know about the courses offered by UVCT and I took up the tailoring course. Now, I am earning up to Rs 3,000 per month. I am very happy that I came to know of this course as they also taught me about LSE (life skills education), and how to overcome my problems.



#### Sandhya Rani

From being 'clueless' to work- from- hometailor.

I am Sandhya Rani, aged 23, married, and stay with my in-laws. I finished my intermediate and was married at an early age. I have a child who is studying in

Nursery. We are family of five members. My husband is an auto driver and earns around Rs 7,000 per month. The money my husband earns was not sufficient to meet the needs of all family members. One of my friends suggested me to take up a tailoring course. I came to know that UVCT offered courses for a very low fee. I joined the course. They were very helpful. Now I work from home and earn around Rs 3,000 per month. Thanks to UVCT!



#### **P Nagamani**

A Beautician equipped with Life Skills to face the world.

I am P Nagamani, 29 years old, married. I am a graduate and have children. I have learned tailoring and beautician course from UVCT. I have also attended few LSE

classes. Now I use my beautician course on Saturday and Sunday, and earn up to Rs 2,500 per month. I am thankful to UVCT as their Life Skills Education classes, helped me to gain confidence in myself. Apart from being a beautician, I work as a teacher in a school and earn up to Rs 5,000 per month. Thanks to UVCT, they really helped me a lot in building my career.



#### Virendra

From being a young man with the sole intention of getting a job to look after his family to being a successful LIC agent.

Nineteen years old Virendra was pursuing his graduation (BA) from an Open University. He was also learning typing to

get hold of some small job to support his family. His father being a vegetable vendor, it was a case of hand to mouth existence for Virendra's family of seven members. Being the eldest in the family, Virendra wanted to help his father in some manner and for that purpose he was learning typing. Later, he got to know about the Comprehensive Skill Development Programme for Beneficiary and Financial Services and the CSR Project of IDBI capital, and decided to join the course. He enjoyed learning the course and used to actively participate in class discussions.

On completion of the course, he joined LIC as an Agent. Now, he has become what you can call an aggressive Sales Agent and his marketing skills are earning him good money. As a result, his family's financial conditions have improved considerably and he has even got his first promotion!

# **Roadmap Ahead**

# **Developing UVCT as a Research Organization on Adolescent-Centric Issues**

UVCT has always been concerned with the welfare of adolescents. It organizes counselling sessions by wellqualified counsellors and psychologists. UVCT, taking into account, the rise in juvenile crimes and the temptations surrounding these children, intends to take up in depth studies related to issues of adolescents. With the advent of technology and exposure to the media, they are found to have a lot many problems than we can think of, especially in cases of children in-conflict-withlaw. Professionals from reputed institutions have been appointed to carry forward this mission of UVCT. A number of topics are being chosen and studies are being conducted by associating IGNOU MA Psychology and MSW students, their internship and Project work. It is a matter of great pride that UVCT is also a study centre for Social Work and Psychology students. More than a hundred students study in our study centre, and this opportunity may be utilized to assign projects and internship topics for them to work on. These could include: effects of body image on adolescents; perception and the reasons behind substance abuse; teenage suicides; stereotyping on academics, etc.

#### Adolescent-Centric Discussion Forum

Adolescents face a lot of issues-right from having questions regarding sexual initiation to peer-pressure and career guidance. There are many issues that children cannot discuss with their parents and parents in turn at times do not know how to answer the questions asked and quench the curiosity among these children. UVCT aims to provide solutions to all their problems. We are aiming for a common platform where children can voice their opinions freely without being judged and without any inhibitions whatsoever. Here, parents, grandparents, and teachers would also be welcome to understand how the adolescent mind works and how to provide solutions to their problems without making them feel embarrassed or guilty. With this goal in mind, UVCT strives to form an adolescent-centric discussion forum where any child can participate and debate and solve their problems.

# Collaboration with Corporate Social Responsibility

The Trust will be in partnership with numerous corporate sectors for the upliftment of Health, Education and

Livelihood of people. For the same, it is planning to take special initiatives to develop programme-based relations with various Public Sector Undertakings (PSUs), Industrial establishments and the academic centres managed by corporate interactions to promote livelihood programmes with the aim to provide placements for trainees for semi-skilled jobs. In fact, one such programme is functioning at Tagore Garden, Delhi, with IDBI-Capital for Comprehensive Skill Development where a 45-day certificate course on basic banking and life-skills education is provided. Another such corporate partnership is carried out at Bhiwandi, Maharashtra, with IDBI Bank for vocational and training courses.

Apart from the above mentioned agenda, UVCT also intends to take the following initiatives into consideration in the coming year,

- New Proposals to NISD, NIPCCD under NCF (drug problem in schools, Website on Adolescents similar to Youth Forum), FICCI, and NHRC. The proposals could range from reformation and rehabilitation of children in- conflict- with- law, bridging the intergenerational gaps between the aged and the adolescents, etc. A project on Premature Deaths is also in the offing, whereby the reasons for teenage suicides, road accidents, and other causes of young adults' deaths would be studied.
- 2. Bringing out a Publication on "Status of Adolescents", similar to that of 'Status on Children" of HAQ. UVCT has a number of publications under its name 'Teenage Blues' (Kishoron ki Komal Duniya), 'Adolescent Concerns Through Own Eyes', and others. This publication will address the problems of the adolescent population and will take a clinical and objective look at the status of the adolescent population across the country.
- 3. Partnering with ChildLine, an MWCD-funded project. Get a centre from them. The Integrated Child Protection Scheme (ICPS) funds the project ChildLine, twenty- four hour service toll-free helpiline service for children in need of care and protection. As UVNAC Building has the infrastructure, it may be utilized for such a wonderful project.
- Project on Road Accidents and sensitizing public, traffic wardens at school junctions; supporting accident victims and their families, liaison with local police and mitigating their problems.



free registration of crimes, and the same has shown a threefold increase in the crime figures in Delhi. He has rightly maintained that burking of crime does not help in crime control, and only worsens the situation on ground.

The Delhi Police has introduced a series of modern measures such as virtualizing the processes involved in Passport Clearance Certificate, filing lost reports, and issuing untraced reports through internet in order to ensure zero-corruption in the system. He confirmed that more such mobile-based applications are in the offing. Mr Bassi is credited for being the only Police Chief who has declared to reward anyone who helps in exposing corrupt practices by the Police.

While addressing the UVCT wards, he was forthright about his humble beginnings (he had studied in a Government School in Tagore Garden, Delhi) and how a focussed approach in life has helped him to come up at this level.

Mr Bassi cleared the Union Public Service Commission examination at the age of 21 and was appointed as an Assistant Superintendant of Police in Pudducherry in 1980. Since then he has served in various capacities in Delhi and other parts of the country, including Arunachal Pradesh, Chandigarh, and Goa. He also remained on deputation to the Intelligence Bureau.

Mr. Bassi, who is a Commerce graduate from the Shri Ram College of Commerce, University of Delhi, also has a Law degree to his credit. He was conferred the President's Police Medal for distinguished service and the Police Medal for meritorious service.

His wife, Ms Sunira Bassi, is also a bureaucrat posted with the Indian Railways. The couple has a daughter and a son.
