### Dear Friends.



With kind cooperation and active support from all of you, Vikram Trust entered into 25th Year. We are happy that the functioning of the Trust could be carried on continuously despite some times, the resource crunch and some other times, crisis in man power. Even the social workers have started insisting on their 'pay packages' while getting interviewed. Problem of emoluments arise especially in case of government-funded projects where the ceilings are set at 'pre-minimum wage' times, and thus, are compartively low. Even if they agree to join with the offered emoluments, they do not hesitate moving away for just 5 to 10% increase in their emoluments. Initial efforts of the NGO to orient them for their specific tasks go waste and we wonder, how long they keep moving on and what would be their ultimate accomplishment.

NGOs with good standing are turning into social enterprises whereas mediocre organizations are either becoming defunct or taking to mere paper work. Two years ago, we thought we should also take to the model of 'social enterprises', but soon realized that our target population, being deprived and marginalized segments, cannot meet bigger demands of fees and perks. We noticed a stark reality in the recently concluded 'IDBI Capital - UVCT Comprehensive programme for Financial services', wherein the stipulated fees of Rs 600/ for a 45-day intensive course and another Rs 600/-, for executive attire(on concessional rates) was found too much by the prospective candidates. As such, we had to overlook the use of executive attire. We, having been committed to social service, may have to carefully keep a balance between income and expenditure.

The Year 2015-16, went off well with our projects. The projects under CSR initiatives of IDBI Bank Ltd and IDBI Capital Services gave us a big boost, besides the STEP programme for training 140 women in "Stitching, Tailoring and Embroidery", of Ministry of Women and Child, GOI. All these programmes have linkages to livelihoods and thus, the outcomes are quite satisfying. We are grateful to Principal and Management of K. V. Penderkar College, Dombivli, Thane District, who helped in designing and conducting a special course "SAIME (Soft Skills, Awareness, IT, Management & Entrepreneurship Development)" for 50 educated but unemployed youngsters, in pursuance of anMOU entered with that college. We are also thankful to the Canara Bank and Andhra Bank, whose teams continued with their short term courses in UVCT Centers, which have been found very useful.

Once again, I like to end thanking my wife, Urivi Chaya, who is also the Vice Chairman controlling the expenditures of the Trust; my other active Executive members and numerous other well wishers and funders. They all give me strength to carry on with these responsibilities.


### About Urivi Vikram Charitable Trust

### **Objectives**



Develop awareness through seminars, group discussions and camps to help young adults find solutions to their problems- psychological, financial, ethical and social.



Help acquire a realistic valve system that is conducive to the development of a healthy society and to develop the concept of oneness of all religions and love for the homeland in the youth, by raising their level of consciousness.



Develop educational and skill training programs for school dropouts and underachievers, to enable them to become not only economically productive but also socially responsible citizens of India and the world.



Develop counseling centre's for the disturbed youths; and to establish rehabilitation centre's for juvenile delinquents to provide both emotional support and skill training.



Develop skills among the young adults and women, in regard to textiles, handicrafts and other ancillary industries.



Endeavor to promote equality of status and opportunity, assuring dignity of individual and the unity and integrity of the Nation, services for the hygiene, health and happiness for all the citizens of India.



Provide Financial Literacy for youth and women in backward communities for employment and formal banking related awairness.

### Advocacy

UVCT actively advocates that adolescence is a "distinct and critical stage" of human development and that there should be more specific schemes, in a coordinated manner, for promoting development of adolescents. UVCT undertook a pioneering advocacy campaign, with several other NGOs and government organizations, for appropriate development of the adolescent population in the country. Its initiative came at a time, to be realistic, when very little had been done on the adolescent agenda. To overcome this lacuna, a National Consultation was held in 1999 on the theme "Towards a policy for young Adults". The Meet resulted in the compilation of an Advocacy document for a "National Policy for Young Adults", which was submitted to the Government of India and the Planning Commission of India. Constituted the first-ever Working Group, including UVCT as a member, which duly brought out a "Report on Adolescents" (2001). In continuation of this initiative, UVCT organized a Regional Seminar in 2002 on "National Policy on Adolescents". It resulted in the first exclusive Scheme of Financial Assistance for Development and Empowerment of Adolescents, in April 2014, with the Ministry of Youth Affairs and Sports as the nodal agency [unfortunately, the scheme lost its identity and got subsumed into an omnibus "National Programme for Youth and Adolescent Development" (NPYAD).] However, UVCT's relentless persuasion and campaign culminated in a joint action by the government agencies and the private organizations in holding the second National Meet in 2005 on "Adolescents: Vision 2020", in a bid to identify the demand-supply gaps. Various government, bilateral, and donor agencies have since eventually incorporated adolescent concerns in their policies and programmes for further development. Yet another National Seminar was held by UVCT in May 2015, on the theme" Demographic Dividend: Challenges of Young People in India", in order to take stock of existing plans and programmes for empowerment of young people and come up with required action plans.

### **UVNAC**

In 2007, the Urivi Vikram Charitable Trust (UVCT) established the Urivi Vikram National Centre of Adolescents (UVNAC) at Dwarka, New Delhi, to carry forward its mission to champion the concerns of the adolescents. This is the India's first Adolescents centre where Psychological support, Career Guidance, and Life skill training is provided to the India's future population. UVNAC is also the National Operation office from where the activities of all the six chapters of UVCT are taken care.





### Highlights of the Year

#### National Seminar on "Demographic Dividend"

UVCT organized a National Seminar, which was partly supported by the Min. of Health and Family Welfare, Govt. of India, on Wednesday, May 6, 2015, in the India International Centre, Max Muller Marg, New Delhi - 110 003. The theme of the seminar has been "Demographic Dividend: Challenges for Young People in India". Demographic dividend, as has been realized, is the accelerated economic growth that results from decline in infant and child mortality, and consequential rise in the number of young population - usually 14 to 30 years - in a country. This is accompanied by an increase of the people of the working age-group (14-65 years), creating opportunity to have less number of economically dependants at household levels. Ratio of working age to dependent population in South Asia, more so in India, is expected to increase for the next 15-20 years, followed by gradual downturn. However, India has not been able to fully reap the advantage of its large stock of population of workable age. Industries, on the other side, are struggling with scarcity of skilled workforce. Progressive actions are needed to take care of future basic minimum living standards including food, water and energy of this promising workforce. Investing in young people, by providing education and employable skills, is critical for their effective utilization.

The Objectives set out for this Seminar have been: Take stock of the policy frameworks on youth development opportunities; Explore potentials of young people for economic and social progress for a common future; Analyze the problems and needs of young people highlighting the core issues, including education, health, mental health, crime, role of parents, teachers and other stakeholders in guiding them; and develop roadmap for the development and empowerment of the young people in the context of targets set to achieve by the year 2022.

Smt. Vandana Kumari Jena IAS, Secretary, Department of Land Resources, Ministry of Rural Development, was the Key note Speaker of the Seminar. Shri. Sunil Arora, IAS, Secretary, Ministry of Skill Development and Entrepreneurship, Govt. of India, was the Guest of Honor. Shri K.Padmanabhaiah, IAS, former Union Home Secretary, gave the concluding remarks. Policy makers, scholars and activists from multi-disciplinary background across the country actively participated in the deliberations, and endevored to come up with a set of doable recommendations for youth development in India. #### Foundation Day

Urivi Vikram Charitable Trust has celebrated its 23rd Foundation Day on 7th December, 2015 at Urivi Vikram National Centre for Adolescents (UVNAC) Building, Sector-22, Dwarka. Sh. Rajeev Gupta, IAS, Secretary, Department of Youth Affairs, Ministry of Youth Affairs and Sports, GOI, has been the Chief Guest, who kindly interacted with the beneficiaries and other respectables of Dwarka. He appreciated the longcontinuing efforts of UVCT for empowerment of adolescents. He acknowledged that the National Centre for Adolescents which he is able to see, is the first Centre of its kind in India. He was happy to learn about the success of the beneficiaries from various Centres from Delhi.





## Support and Training For Empowerment of Women Programme (STEP)

STEP programme, a project of the Ministry of Woman and Child Development, was the major programme of the centre launched on 6th Oct 2015. The duration of first batch was six months and 72 students were enrolled and learnt art of stitching and tailoring together with embroidery. Students are provided midday meals and travel allowance as part of programme. Tailoring tools and materials also provided to relieve them from their financial problems. The project aims at women empowerment through entrepreneurship and self employment. The intention of the programme is to help women in supplementing their family incomes.

On the occasion of finale of first batch training, UVCT has organized fashion show to keep up the "enthusiasm" and to further motivate students. Trainees got platform to perform their talents by making dress with various modern and traditional appearances.

The fashion show was held towards the end of first batch as a graduating ceremony for the passing out. Ms. Geetha Pathak, women empowerment expert, Ms. Manju Singh Principle and Head, National placement cell, ATDC were present as dignitaries. Guests were present from the garment industry to view the show and guide students further. (Detail Report under Bindapur Centre)



## TOT in Career Guidance and Counseling in Visakhapatnam

Under the auspices of Rajiv Gandhi National Institute of Youth Development (RGNIYD), MYAS, Govt. of India, a 5-day intensive TRAINING OF TRAINERS (TOT) ON CAREER GUIDANCE AND COUNSELLING was conducted for 40 teachers/lecturers in Visakhapatnam from 8th to 12th February, 2016. The TOT was inaugurated by Prof V. Umamaheswara Rao, Registrar, Andhra University and Key Note Address was delivered by Prof M.V.R. Raju, HOD, Psychology Dept., A U. Prof N.A.D.Pal., N.S.S Program Coordinator, Visakhapatnam delivered the Valedictory address and helped in preparation of Action Plans by the participants as to how they would be utilizing the orientation received by them. Dr Surapuneni Vijaykumar of Vijay Nirman graced the valediction.

Eminent academicians and practitioners could be enlisted as Resource persons. The topics set out for the interactive sessions have been: Understanding the issues pertaining to adolescents and world of work; Importance and need of Career counseling; Counseling processes and skills; Aptitude assessment and career choice; career preparedness skills; Career Profiling and report writing. The participants actively partook in the sessions and the role plays, by sharing their experiences and tried to correct their wrong perceptions about career guidance. More than half of the participants are from government schools located in remote areas and thus, the inputs were valued and well received. The programme was rated high - 22% (Excellent) and 59% (Very good). The TOT promoted new initiatives in the participants who continue to interact and promote concepts of counseling and career guidance by forming WhatsApp groups. The other important outcome of the TOT has been a boost to the Rural Counseling programmes of the UVCT.











#### **IDBI BANK CSR Initiative**

IDBI Bank supported UVCT to conduct various programmes for the underprivileged in the Thane District of Maharashtra. The Project made difference in the lives of 2318 individuals in the locality and benefited in various segments. Project included programmes like Vocational Training; Psycho-Social Intervention at schools and Community Level; Parents Teachers Meets; School outreach programmes and SAIME. Mrs. Paranjape, CGM (CSR) and Mr. Jijo Vadukoot, Manager, CSR wing of IDBI Bank graced the prize distribution function of the school outreach and vocational transining programmes held in Kalyan.



#### **IDBI Capital CSR Initiative**

IDBI Capital supported UVCT to conduct Financial Literacy Comprehensive Skill Development Programme to train underprivileged young adults. The one year project was carried out during the last fiscal to develop underprivileged in the area of Tagore Garden and Bindapur, West Delhi. The six-week training programme helped 500 students to reach to an economical independency by being employed, through the placement guidance, in the financial and insurance sectors.











### Tagore Garden Skill Development Centre


UVCT Skill Development Centre at Tagore Garden, West Delhi continued to serve the underprivileged population in the area. It is the 18th year of commitment for the people at Tagore Garden and nearby localities. A total of 1888 students were benefited in this fiscal. The centre skilled young people and women in the undermentioned courses:

- Computer Application
- Cutting & tailoring
- Handicrafts
- Beauty culture
- Typewriting and Stenography
- Spoken English
- Life skills Training
- Comprehensive course in financial literacy

As usual, women enthusiastically participated in larger numbers (83% of total beneficiaries) in the job-linked courses and endeavored to empower themselves. Beauty culture and Cutting and Tailoring program are exclusively for the women group. After the training and certification, women could boost their income through taking up jobs or self employment.

The majority of the population in the area are migrants who are from different states came in search of jobs and settled in the area. Middle and low income families are


facing difficulty to send their children for higher education in regular colleges. Many such children pursue their studies through correspondence courses and simultaneously try improving their employable skills. School drop outs and unemployed are a common factor of the area, for whom UVCT has been striving to improve their livelihoods. The highly subsidized fees structure (e.g a fees of Rs 1000 for a three month computer applications course, whereas the market rate is Rs 5000 and above) is enabling them to avail these vocational programmes. A Library cum Reading room facility is also created in the premises with the support received from Canara Bank. The UVCT Staff and student volunteers were committed to make a difference in the lives of the underprivileged. A. number of officials and local leaders visited the Centre during this fiscal and encouraged/ supported the developmental programmes of UVCT.







Out of total Number of 1888 trainees, 87.07% passed out and certified in their respective courses.

The above diagram shows the commitment of UVCT in women empowerment. Reaching to women in the community through various means to improve them economically and socially through the skill development, is the mission of UVCT, that is being fulfilled year after year.



The age breakup confirms that young people in the age group of 14 to 17 yrs are also eager to build their skills alongside their school education, while those who are in age of 17 to 23 yrs are in post-school level - mostly drop outs and underachievers -who are encouraged to improve their employable skills. Computer applications is the most popular course, followed by Beauty Culture. The participants in the age group of 23yrs and above are mostly married women who are keen to supplement their family incomes.










### **UVCT Bindapur Skill Development Centre**

Bindapur centre of UVCT has been working since 2013 for the empowerment of underprivileged youth and women. Bindapur is a densely populated area of West Delhi with low income families and unemployed women. UVCT is into changing the lives of women in the locality through various programmes.STEP programme (a Scheme of Min of Women and Child Development, Govt. of India) in Stitching, Tailoring and Embroidery has been a major activity in the Centre, which offered a 6-month intensive course with linkages to livelihood, to about 140 women of the area. It was a programme conducted under the care of a NIFT qualified senior trainer and thus, its standards have been kept high. Additionally, another 350 beneficiaries attended the under mentioned courses and found their way ahead for success in life.

- Comprehensive Course in Financial Literacy
- Beauty Culture
- Cutting and Tailoring (Basic)
- Computer Applications
- Dress making
- Remedial classes (underprivileged children from the area are supported by remedial classes in the centre)
- Life skills Education

The centre also conducted short time courses in soft toys making, candle making and hand-bag making through Canara Bank experts, to provide skills for improving their livelihoods.




Total enrolment of the fiscal was 475, out of whom 439 has successfully completed their course











Gender based analysis of each course glorify the women empowerment initiatives of the centre. It also showed keenness of women to improve their lot.



The majority of trainees are in the age group of 20 to 23 and a minimum percentage above the age of 32.



88% of the total students were Females.



It is found that 26% of trained could find jobs and 12 % took to self employment. 5% have turned to entrepreneurship in the sectors like beauty culture and dress making. Others used for self enrichment and went into higher studies.







### Gender Resource Center (GRC), Kapashera





GRC in the fiscal year reached out to 7449 underprivileged people, with support to bring empower themselves. Different programmes of GRC were OPD's, Vocational courses, Health and nutrition camps, Legal sessions, SHGs, and Information Centre.

Legal support is provided to those who are in need and eight new SHGs were promoted, out of which two were linked with banks for livelihood enhancement of the members. The Information centre operating in GRC received as many as 3737 enquiries.

Unfortunately, the present State Government opted to close the 140 odd GRCs in Delhi, which were providing yemen service to under privileged people in slum and rehabilitation colonies, at a total annual budget of about Rs. 20 Crores. About 2000 Mohalla Committees were supposed to be started as replacement to GRCs, which process was going on for some time.

### Target Intervention (TI) At Wazirpur

Targeted Intervention Center of UVCT is located in Wazirpur Industrial Area, North-West district of Delhi, which aims to help the migrant population living in that area. People living away from families and belong to different States constitute High Risk Group (HRG). ICTC services, Health Camps, Awareness programmes, Outreach programmes, Registration of HRGs, and condom promotions are some activities which are conducted to reach out the target population.

#### Activities conducted this year:

Meetings with the Sta

Meetings with the Stakeholders of the industrial area were held to know the problems faced by the migrants. Efforts were made to resolve those problems.

Advocacy service was provided to the migrants for their betterment and improving their living conditions and life styles.

Counseling service was provided to the migrants to create awareness about STDs, HIV/AIDS and others problems. Efforts were made to help the affected person and their families as well as to change the risky behavior of the HRGs.

Medical services and medicinal facility was provided to the HRGs and STI patients.

IEC, Health education, Health promotion, Aids Education and social marketing services were also provided to the migrant population.

### **IGNOU**





IGNOU study center was started in 2010, with just 250 learners. UVCT takes pride in its academic services and other facilities, which promted a 6-fold increase in learners, totalling to 1559 in 2015-16. MA (Psychology) with about 515 leaners and BSW / MSW with about 450 learners are the most populous courses of the Study Center. A total of 340 learners entered into BA (Psy) courses. A number of workshops and the interactive sessions are held in UVNAC, over and above their curriculum, to improve their knowledge base. A course wise break up is given below.

### Empowerment of women by equipping them with Vocational and Life Skills


IDBI CSR Initiative could reach to 698 women (against a target of 600) in the underprivileged communies, with vocational skills in various trades.

The majority of the beneficiaries were working as domestic helpers who turned to various trades on post training for their economic growth. Self employment became the supportive income source for many women in the locality, mostly adding Rs 2000 to 3000 to their monthly incomes.

### Psycho-Social Intervention at schools and Community Level

Programme catered to 47 adolescents with psychological support. Based on their situation and psychic level, team could guide them to a better level.

#### **Parents Teachers Meets**

As one of the component of IDBI CSR Project, Parenting sessions were organized in schools and communities. 10 sessions were organized and by the experts in the field, where in 316 parents were benefited with good parenting guidance.



#### School outreach programmes

School Outreach programmes were conducted in the fiscal in 15 schools. The programme included drawing and essays competitions together with Life Skill Education. Ms. Paranjape, CGM, IDBI Bank, has decorated the winners with Medals.




#### SAIME

Soft Skills, Awareness, IT, Management & Entrepreneurship Development (SAIME) programme, was developed to train Graduates and Undergraduates with basic computer, English Speaking, Marketing Skills and Life Skills. Due to the programme, 50 graduates were gainfully employed. The 150 hour long course was a comprehensive skilling programme, developed with the support of K.V. Pendharkar college, Dombivli.

#### Visakhapatnam Chapter

UVCT Visakhapatnam Chapter excelled with their progammes in the fiscal, like Life Skill Trainings, Parents meets, Individual Counseling, Rural Counseling, TOT on Career Guidance and Counseling for Youth Functionaries, Workshop for unemployed youth on how to prepare for competitive examinations, Adolescent Center, and VPT - UVCT Yuva Shakti Centre.

#### **CAREER MELAS:**

The center conducted 6 out-reach programs in and around Visakhapatnam. Nearly 600 students were benefited from out-reach programs. Lectures on Career Awareness & Career Planning, Career Guidance and New Emerging Careers were given. Various activities were conducted at Tekkali and Visakhapatnam under the supervision of young and vibrant team.





#### Life skills training programs:

The UVCT Visakha center organized 6 Life Skills Education Programmes-one in Govt. Boys home; two programmes in Govt. girls observation home; PAPA homel; Manasu Ngo's, and Arilova office premises. It was a 20-day programme, 3 hours a day. It is supported by

MYAS, under NPYAD. A total 120 children were benefited, out of whome 60% were those indulging in social crimes. These children having no one to guide them, often tended to indulge in anti-social activities such as gambling, smoking and petty thefts and at times, were forcibly dragged into homosexual relationships, and learning the jungle code of 'survival of the fittest' quite early in life. They survived on left-over food stuff from railway carriages or from garbage bins. They were mostly under achievers and drop-out children.



#### **Parental Meets:**

Two parent meets were organized where in a total of 132 parents participated. First workshop for parents was conducted on 29th July, 2015 in Meeting hall of Indhra Kranthipadam, Bheemili, Visakhapatnam. 60 parents were from fisherman community participated in the programme. Mr. R.Naresh, Career Counselor, UVCT educated them about the children general behavior, and bad habits; he also focused on the role of parents in helping children to overcome those problems.



Second parental meet was conducted in coordination

with Visakhapatnam Port Trust on 9th November 2015 at Port High School, Salagramapuram, Visakhaptnam. About 72 parents participated in the programme actively.

Technical session was held where lectures were given on how to cope up with children's disappointments and how to know your growing child by K.Swathi yadav; and role of parents in choosing the careers of their children was discussed by Mr. Naresh, the career counselor of UVCT Visakha

#### CAREER MELAS IN TEKKALI:

Career Counseling Programme was organized on 7th and 8th of January in Tekkali, Srikakulam District. The main objectives of the programme were to create awareness about various career options available and also to supplement them with Studying habits and Memory techniques.



Around 1000 students participated in a span of two days. Information on why Life skills are needed for one's personal development and various scholarships that are offered for students to support their education was given.

The programme helped to make children aware of the different career options available. The program was highly appreciated by the participants and teachers alike. The highlight of the programme was the kind pressance



of prof. Latpat Rai, The Vice-Chacellor of Shri Ambedkar University, Srikakulam, alongwith a visiting South Korean expert team.

Dr. U.N.B.Rao, School Headmaster Sri T.JogaRao, Junior College Principal S.BheemeswarRao, Dr.Ch.TirupatiRao, GovindaRaoGaru and other staff of school and college attended the programme.

### Workshop for unemployed youth on how to get into livelihoods.

The UVCT Visakha center had conducted a workshop for unemployed, but qualified youth on 20th Jan 2016 at Visakha public library. Topics covered were about startups and entrepreneurship by GM of Dist. Industrial Center; and how to prepare for competitive examinations by Dr.UNBRao, IPS (Retd.), Chairman of UVCT; along with comprehensive English and Interview techniques by Professors of L.B College Dr. Radha Devi & Dr.Jayasree Shetty. Nearly 70 youth participated in the workshop.



#### **VPT - UVCT Adolescent Center**

Urivi Vikram Charitable Trust and Visakhapatnam Port Trust (a CSR Initiative of VPT) jointly launched VPT - UVCT Adolescent Center, at Shree Saradha Mahila Samajam, Salagramapuram, Visakhapatnam on 3rd February 2016. It was launched by Shri.P.L Harinath, I.R.T.S, Deputy Chairman, VPT who was also the Chief Guest of the occasion, along with the Guests of Honors Smt.Vijayalaxmi, DGM, Andhra Bank and Dr. S. Vijay kumar, CMD, Vijay Nirman Company. Dr. UNB Rao, I.P.S, (Retd.) Chairman UVCT and Cmde.ChinnaVerriyya (Retd.) Executive Secretary have graced the event. Dr. UNB Rao conducted a session on services and significance of the VPT - UVCT Adolescents.

The Center provided counseling to the adolescent

students and their parents, to help children to have a bright future and become role models to the next generation. Nearly 50 Parents and staff of VPT have actively participated in the program

UVCT organized Training of Trainers on Career Guidance and Counseling for Youth Functionaries on 12th Feb 2016 to 16th Feb 2016 at Dhyan Ashram, Chinnawaltaire, Visakhapatnam. With support of Rajiv Gandhi National Institute of Youth Development (RGNIYD). The programme was inaugurated by Prof V. Uma Maheswara Rao, Hon'ble Registrar of Andhra University. He appreciated the concept of training teaching community so that they, in turn, could extend the much-needed career counseling to a wider section of young people. He lauded RGNIYD for extending this TOT in Visakhapatnam and added that UVCT is ably suited to fulfill the objectives of the programme. He wished that such TOTs shall be conducted by RGNIYD periodically and at least once a year.

Prof M V R Raju, delivered the Key Note Address covering the total ambit of the TOT and impressed on the need for career counseling to the young people in the modern world.



#### Tekkali: Rural Counseling Activities:

The Urivi Vikram Charitable Trust, Tekkali center conducted 3 out-reach programs in surroundings of Tekkali, i.e. ZHPS, Vanjangi, Amudalavalasa Mandal[ZPH School, Ravivalasa; and Govt. Junior College, Tekkali. Nearly 250 students were benefited. The participants were from 8th to 12th classes. Mr. Naresh, Career Counsellor of UVCT spoke about career planning, goal setting and what are the career

opportunities after 10th class. Mrs. J. Surya Kumari, Psychological Counsellor, talked about study habits and memory techniques.

#### **Individual Counseling:**

As part of Rural counseling, the Trust counselor visited Tekkali frequently. 113 students from surroundings of Tekkali have been provided individual counseling, that heled 10 of them getting into different Govt. services.

My husband's income was very low and so I was desperately searching for a job but due to lack of education I wasn't able to find a one. I came in contact with the personnel of UVCT vocational Training Centre where in was persuaded to undergo the Beauty Culture Program. After the completion of the course I started running my own beauty parlor at home and now earn around Rs.7000. I am very thankful to UVCT.

#### Madhu

I have two children. Basically, I am from Chandari, U.P. but currently I am living in Kapsahera on rent. One day I came to know about the SHG running by UVCT where I got enrolled in bag making and art handicraft work. Some other vocational trainings were also been conducting at SHG, UVCT Kapsahera Centre. There I learnt how to make bags from jute and threads. Then I started making such bags at my home and sold them. After some time, demand was increased and I was suggested to have a small shop and I got a place at Sadar Market for the same. 
