
## State Chapter & Activities......

#### **DELHI**

#### Skill Development Centre, Tagore Garden, New Delhi

- The centre skilled young people and women in the undermentioned courses in Computer Application, Cutting & Tailoring, Handicrafts, Beauty Culture, Typewriting and Stenography, Spoken English, Life Skills Training and Course In Financial Literacy
- The centre was reopend on July 2021 after the lockdown due to Covid-19 pandamic (it was closed from March 2021)
- During lockdown, the centre provided all the possible support related to course through online modes.
- A Legal Aid Camp was organised in collaboration with Delhi State Legal Services Authority (DLSA) on September 13, 2021. Many women from surrounding attended the camp seeking legal advise.
- Aadhar card has become the basic need of everyone nowadays. And due to the epidemic, people have trouble in using government facilities related to Aadhar
  - card.Keeping this in mind, a camp was organisedin collaboration with Delhi State Legal Services Authority (DLSA) for correction in Aadhar card on September 13, 2021, Local people participated in the camp in large number.
- Students: At present 31 students in Dress designing, 10 in Coumputer basics and 3 for English typing are enrolled.





#### Target Intervention Centre (TI), Wazirpur, New Delhi


- The main activity of the center is to help the migrant population living in the area, people living away from families and belong to different States constitute High Risk Group (HRG)
- ❖ Providing ICTC services, organising Health Camps, Awareness programmes, Outreach programmes, Registration of HRGs, and condom promotions are some activities which are conducted to reach out the target population.



#### **UVCT Childline at Kalyan Stattion**


